- Sec. 8433.002. NATURE OF DISTRICT. The district is a 18
- 19 municipal utility district created under Section 59, Article XVI,
- Texas Constitution. 20
- 21 Sec. 8433.003. CONFIRMATION AND DIRECTORS' ELECTION
- REQUIRED. The temporary directors shall hold an election to 22
- confirm the creation of the district and to elect five permanent 23
- directors as provided by Section 49.102, Water Code. 24

- 1 Sec. 8433.004. CONSENT OF MUNICIPALITY REQUIRED. The
- 2 temporary directors may not hold an election under Section 8433.003
- 3 until each municipality in whose corporate limits or
- 4 extraterritorial jurisdiction the district is located has
- 5 consented by ordinance or resolution to the creation of the
- 6 district and to the inclusion of land in the district.
- 7 Sec. 8433.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
- 8 The district is created to serve a public purpose and benefit.
- 9 (b) The district is created to accomplish the purposes of:
- 10 (1) a municipal utility district as provided by
- 11 general law and Section 59, Article XVI, Texas Constitution; and
- 12 (2) Section 52, Article III, Texas Constitution, that
- 13 relate to the construction, acquisition, or improvement of
- 14 macadamized, graveled, or paved roads described by Section 54.234,
- 15 Water Code, or improvements, including storm drainage, in aid of
- 16 those roads.
- 17 Sec. 8433.006. INITIAL DISTRICT TERRITORY. (a) The
- 18 district is initially composed of the territory described by
- 19 Section 2 of the Act enacting this chapter.
- 20 (b) The boundaries and field notes contained in Section 2 of
- 21 the Act enacting this chapter form a closure. A mistake made in the
- 22 field notes or in copying the field notes in the legislative process
- 23 <u>does not affect the district's:</u>
- 24 (1) organization, existence, or validity;
- 25 (2) right to issue any type of bond for the purposes
- 26 for which the district is created or to pay the principal of and
- 27 interest on a bond;

1 (3) right to impose a tax; or 2 (4) legality or operation. SUBCHAPTER B. BOARD OF DIRECTORS 3 Sec. 8433.051. GOVERNING BODY; TERMS. (a) The district is 4 5 governed by a board of five elected directors. 6 (b) Except as provided by Section 8433.052, directors serve 7 staggered four-year terms. 8 Sec. 8433.052. TEMPORARY DIRECTORS. (a) On or after the effective date of the Act enacting this chapter, the owner or owners of a majority of the assessed value of the real property in the 10 district may submit a petition to the commission requesting that 11 12 the commission appoint as temporary directors the five persons named in the petition. The commission shall appoint as temporary 13 14 directors the five persons named in the petition. 15 (b) Temporary directors serve until the earlier of: 16 (1) the date permanent directors are elected under 17 Section 8433.003; or (2) the fourth anniversary of the effective date of 18 19 the Act enacting this chapter. (c) If permanent directors have not been elected under 20 Section 8433.003 and the terms of the temporary directors have 21 expired, successor temporary directors shall be appointed or 22 reappointed as provided by Subsection (d) to serve terms that 23 24 expire on the earlier of: 25 (1) the date permanent directors are elected under 26 Section 8433.003; or

(2) the fourth anniversary of the date of

- 2 (d) If Subsection (c) applies, the owner or owners of a
- 3 majority of the assessed value of the real property in the district
- 4 may submit a petition to the commission requesting that the
- 5 commission appoint as successor temporary directors the five

- 7 successor temporary directors the five persons named in the
- 8 petition.
- 9 <u>SUBCHAPTER C. POWERS AND DUTIES</u>
- 10 Sec. 8433.101. GENERAL POWERS AND DUTIES. The district has
- 11 the powers and duties necessary to accomplish the purposes for
- 12 which the district is created.
- 13 Sec. 8433.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 14 DUTIES. The district has the powers and duties provided by the
- 15 general law of this state, including Chapters 49 and 54, Water Code,
- 16 applicable to municipal utility districts created under Section 59,
- 17 Article XVI, Texas Constitution.
- 18 Sec. 8433.103. AUTHORITY FOR ROAD PROJECTS. (a) Under
- 19 Section 52, Article III, Texas Constitution, the district may
- 20 design, acquire, construct, finance, issue bonds for, improve, and
- 21 convey to this state, a county, or a municipality for operation and
- 22 maintenance macadamized, graveled, or paved roads described by
- 23 Section 54.234, Water Code, or improvements, including storm

- 2 may not undertake a road project authorized by Section 8433.103

- 6 road project, if a municipality or county will operate and maintain
- 7 the road; or
- 8 (2) the Texas Transportation Commission has approved

- 19 creation of the district or to the inclusion of land in the
- 20 district.
- 21 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- Sec. 8433.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
- 23 district may issue, without an election, bonds and other
- 24 obligations secured by:
- 25 (1) revenue other than ad valorem taxes; or
- 26 (2) contract payments described by Section 8433.153.
- 27 (b) The district must hold an election in the manner

- 1 provided by Chapters 49 and 54, Water Code, to obtain voter approval

- 8 Sec. 8433.152. OPERATION AND MAINTENANCE TAX. (a) If
- 9 authorized at an election held under Section 8433.151, the district
- 10 may impose an operation and maintenance tax on taxable property in
- 11 the district in accordance with Section 49.107, Water Code.
- 12 (b) The board shall determine the tax rate. The rate may not
- 13 exceed the rate approved at the election.
- 14 Sec. 8433.153. CONTRACT TAXES. (a) In accordance with
- 15 Section 49.108, Water Code, the district may impose a tax other than
- 16 an operation and maintenance tax and use the revenue derived from
- 17 the tax to make payments under a contract after the provisions of
- 18 the contract have been approved by a majority of the district voters
- 19 voting at an election held for that purpose.

- 3 Sec. 8433.202. TAXES FOR BONDS. At the time the district
- 4 issues bonds payable wholly or partly from ad valorem taxes, the
- 5 board shall provide for the annual imposition of a continuing
- 6 direct ad valorem tax, without limit as to rate or amount, while all
- 7 or part of the bonds are outstanding as required and in the manner
- 8 provided by Sections 54.601 and 54.602, Water Code.
- 9 Sec. 8433.203. BONDS FOR ROAD PROJECTS. At the time of
- 10 issuance, the total principal amount of bonds or other obligations
- 11 issued or incurred to finance road projects and payable from ad
- 12 valorem taxes may not exceed one-fourth of the assessed value of the
- 13 real property in the district.

- 1 SECTION 3. (a) The legal notice of the intention to
- 2 introduce this Act, setting forth the general substance of this
- 3 Act, has been published as provided by law, and the notice and a
- 4 copy of this Act have been furnished to all persons, agencies,
- 5 officials, or entities to which they are required to be furnished
- 6 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

- 8 (b) The governor, one of the required recipients, has
- 9 submitted the notice and Act to the Texas Commission on

- 11 (c) The Texas Commission on Environmental Quality has filed
- 12 its recommendations relating to this Act with the governor, the
