A BILL TO BE ENTITLED

- 2 relating to the authority of the Midland County Hospital District
- 3 of Midland County, Texas, to employ and commission peace officers.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter C, Chapter 1061, Special District
- 6 Local Laws Code, is amended by adding Section 1061.121 to read as
- 7 follows:
- 8 Sec. 1061.121. EMPLOYMENT OF DISTRICT PEACE OFFICERS. (a)
- 9 The board may employ and commission peace officers for the
- 10 district.
- 11 (b) The jurisdiction of a peace officer commissioned under
- 12 this section includes the property owned or controlled by the
- 13 district and any street abutting, right-of-way over or through, or
- 14 <u>easement in the property.</u>
- 15 (c) In a district peace officer's jurisdiction, the peace
- 16 officer has the authority granted by Chapter 14, Code of Criminal
- 17 Procedure. The peace officer may also make an arrest without a
- 18 warrant in the officer's jurisdiction if the offense involves
- 19 injury or harm to any property owned or controlled by the district.
- 20 SECTION 2. Article 2.12, Code of Criminal Procedure, is
- 21 amended to read as follows:
- 22 Art. 2.12. WHO ARE PEACE OFFICERS. The following are peace

- 13 (5) investigators of the district attorneys', criminal

- 19 SECTION 3. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect September 1, 2013.
