Section 1069.060, Special District Local Laws Code, as effective April 1, 2013, is amended by adding Subsection 10 11 (b-1) and amending Subsection (c) to read as follows: 12 (b-1) The board may employ physicians, but only as provided by Section 1069.0605. 13 14 Except as provided by Section 1069.0605, the [The] board (c) may provide that the district administrator has the authority to 15 16 employ district employees, including technicians and nurses. SECTION 3. Subchapter B, Chapter 1069, Special District 17 Local Laws Code, as effective April 1, 2013, is amended by adding 18 Section 1069.0605 to read as follows: 19 Sec. 1069.0605. EMPLOYMENT OF PHYSICIANS. (a) The board 20 21 may employ a physician and retain all or part of the professional income generated by the physician for medical services provided at 22 23 a hospital or other health care facility owned or operated by the district if the board satisfies the requirements of this section. 24

4	(2) adopt, maintain, and enforce policies to ensure
5	that a physician employed by the district exercises the physician's
6	independent medical judgment in providing care to patients.
7	(c) The policies adopted under this section must include:
8	(1) policies relating to:
9	(A) credentialing and privileges;
10	(B) quality assurance;
11	(C) utilization review;

(h) A physician employed by the district shall retain 10 independent medical judgment in providing care to patients and may 11 12 not be disciplined for reasonably advocating for patient care. (i) If the district provides professional liability 13 14 coverage for physicians employed by the district, a physician 15 employed by the district may participate in the selection of the professional liability coverage, has the right to an independent 16 17 defense at the physician's own cost, and retains the right to consent to the settlement of any action or proceeding brought 18 19 against the physician. (j) If a physician employed by the district enters into an 20 employment agreement that includes a covenant not to compete, the 21 agreement is subject to Section 15.50, Business & Commerce Code. 22 (k) The board may not delegate to the chief executive 23 24 officer of the district the authority to hire a physician. 25 (1) This section applies to medical services provided by a 26 physician at a hospital or other health care facility owned or

(m) The authority granted to the board under this section to 1 2 employ physicians shall apply as necessary for the district to fulfill the district's statutory mandate to provide medical care 3 for the indigent and needy residents of the district as provided by 4 5 Section 1069.101. 6 (n) This section may not be construed as authorizing the board to supervise or control the practice of medicine as 7 prohibited under Subtitle B, Title 3, Occupations Code. 8 SECTION 4. This Act takes effect immediately if it receives 9 a vote of two-thirds of all the members elected to each house, as 10 provided by Section 39, Article III, Texas Constitution. If this 11 Act does not receive the vote necessary for immediate effect, this 12 Act takes effect September 1, 2013. 13
