1	weeks a substantial copy of the election order in a newspaper with

3	(f) The first publication of the notice must appear not

5	(g) The ballot for an election under this section must be

9	section favor dissolution, the board of directors shall find that

1 share of all unused tax money.

2 <u>(q) A taxpayer may request that the taxpayer's share of</u> 3 <u>surplus tax money be credited to the taxpayer's county taxes. If a</u> 4 <u>taxpayer requests the credit, the board of directors shall direct</u> 5 <u>the secretary to transmit the money to the county tax</u> 6 <u>assessor-collector.</u>

7 (r) After the District has paid all debts of the District 8 and has disposed of all money and other assets of the District as 9 prescribed by this section, the board of directors shall file a 10 written report with the Commissioners Court of Eastland County 11 summarizing the board's actions in dissolving the District.

12 (s) Not later than the 10th day after the date the 13 Commissioners Court of Eastland County receives the report and 14 determines that the requirements of this section have been 15 fulfilled, the commissioners court shall enter an order dissolving 16 the District and releasing the board of directors from any further 17 duty or obligation.

18 (t) If all positions on the board of directors of the 19 District are vacant, the county judge of Eastland County has all the 20 powers and duties otherwise provided by law to the board of 21 directors of the District.

SECTION 2. All proceedings, resolutions, orders, and other acts or attempted acts of the board of directors of the Cisco Hospital District relating to the intended dissolution of the district and the sale or transfer of any district assets and liabilities pursuant to the intended dissolution of the district occurring before the effective date of this Act are validated in all

respects as of the dates they occurred and may not be held invalid
because they were not performed in accordance with law.

3 SECTION 3. This Act takes effect immediately if it receives 4 a vote of two-thirds of all the members elected to each house, as 5 provided by Section 39, Article III, Texas Constitution. If this 6 Act does not receive the vote necessary for immediate effect, this 7 Act takes effect September 1, 2013.
