- Sec. 8414.002. NATURE OF DISTRICT. The district is a 18
- 19 municipal utility district created under Section 59, Article XVI,
- 20 Texas Constitution.
- 21 Sec. 8414.003. CONFIRMATION AND DIRECTORS' ELECTION
- REQUIRED. The temporary directors shall hold an election to 22
- confirm the creation of the district and to elect five permanent 23
- 24 directors as provided by Section 49.102, Water Code.

- C.S.H.B. No. 1260 Sec. 8414.004. CONSENT OF MUNICIPALITY REQUIRED. 1 2 temporary directors may not hold an election under Section 8414.003 until each municipality in whose corporate limits or 3 extraterritorial jurisdiction the district is located 4 has consented by ordinance or resolution to the creation of the 5 district and to the inclusion of land in the district. 6 7 Sec. 8414.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) 8 The district is created to serve a public purpose and benefit. 9 (b) The district is created to accomplish the purposes of: (1) a municipal utility district as provided by 10 general law and Section 59, Article XVI, Texas Constitution; and 11 12 (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, 13 or maintenance of macadamized, graveled, or paved roads, or 14 15 improvements, including storm drainage, in aid of those roads. Sec. 8414.006. INITIAL DISTRICT TERRITORY. (a) The 16 17 district is initially composed of the territory described by Section 2 of the Act enacting this chapter. 18 19 (b) The boundaries and field notes contained in Section 2 of the Act enacting this chapter form a closure. A mistake made in the 20 21 field notes or in copying the field notes in the legislative process
- 23 (1) organization, existence, or validity;

TEMPORARY DIRECTORS. (a) The temporary board consists of: 25 26 (1) Bill Odle;

(2) Brandon Macey;

1 (3) Troy Koteras; 2 (4) Greg Snider; and 3 (5) Abby McMahon. (b) Temporary directors serve until the earlier of: 4 5 (1) the date permanent directors are elected under 6 Section 8414.003; or 7 (2) the fourth anniversary of the effective date of the Act enacting this chapter. 8 (c) If permanent directors have not been elected under 9 Section 8414.003 and the terms of the temporary directors have 10 expired, successor temporary directors shall be appointed or 11 reappointed as provided by Subsection (d) to serve terms that 12 expire on the earlier of: 13 14 (1) the date permanent directors are elected under 15 Section 8414.003; or 16 (2) the fourth anniversary of the date of the 17 appointment or reappointment. (d) If Subsection (c) applies, the owner or owners of a 18 19 majority of the assessed value of the real property in the district may submit a petition to the commission requesting that the 20 commission appoint as successor temporary directors the five 21 persons named in the petition. The commission shall appoint as 22 successor temporary directors the five persons named in the 23 24 petition. 25 SUBCHAPTER C. POWERS AND DUTIES 26 Sec. 8414.101. GENERAL POWERS AND DUTIES. The district has

the powers and duties necessary to accomplish the purposes for

- 2 Sec. 8414.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 3 DUTIES. The district has the powers and duties provided by the
- 4 general law of this state, including Chapters 49 and 54, Water Code,
- 5 applicable to municipal utility districts created under Section 59,
- 6 Article XVI, Texas Constitution.
- 7 Sec. 8414.103. AUTHORITY FOR ROAD PROJECTS. Under Section
- 8 52, Article III, Texas Constitution, the district may design,
- 9 acquire, construct, finance, issue bonds for, improve, operate,
- 10 maintain, and convey to this state, a county, or a municipality for
- 11 operation and maintenance macadamized, graveled, or paved roads, or
- 12 improvements, including storm drainage, in aid of those roads.
- Sec. 8414.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road
- 14 project must meet all applicable construction standards, zoning and
- 15 subdivision requirements, and regulations of each municipality in
- 16 whose corporate limits or extraterritorial jurisdiction the road
- 17 project is located.
- 18 (b) If a road project is not located in the corporate limits
- 19 or extraterritorial jurisdiction of a municipality, the road
- 20 project must meet all applicable construction standards,
- 21 subdivision requirements, and regulations of each county in which
- 22 the road project is located.
- 23 <u>(c) If the state will maintain and operate the road, the</u>
- 24 Texas Transportation Commission must approve the plans and
- 25 specifications of the road project.
- Sec. 8414.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
- 27 OR RESOLUTION. (a) The district shall comply with all applicable

- 1 requirements of any ordinance or resolution that is adopted under
- 2 Section 54.016 or 54.0165, Water Code, and that consents to the
- 3 creation of the district or to the inclusion of land in the
- 4 district.
- 5 (b) In addition to all the rights and remedies provided by
- 6 other law, if the district violates the terms of an ordinance or
- 7 resolution described by Subsection (a), the municipality is
- 8 entitled to injunctive relief or a writ of mandamus issued by a
- 9 court requiring the district and the district's officials to
- 10 observe and comply with the terms of the ordinance or resolution.
- 11 Sec. 8414.106. EFFECT OF ANNEXATION OR INCLUSION WITHIN THE
- 12 CORPORATE BOUNDARIES OF THE CITY OF CONROE. Notwithstanding Section
- 13 54.016(f)(2), Water Code, an allocation agreement between the City
- 14 of Conroe and the district that provides for the allocation of the
- 15 taxes or revenues of the district and the city following the date of
- 16 <u>inclusion of all the district's territory in the corporate limits</u>
- 17 of the city may provide that the total annual ad valorem taxes
- 18 collected by the city and the district from taxable property in the
- 19 district may exceed the city's ad valorem tax on that property.
- Sec. 8414.107. LIMITATION ON USE OF EMINENT DOMAIN. The
- 21 district may not exercise the power of eminent domain outside the
- 22 district without the written consent of the City of Conroe.
- 23 <u>SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS</u>
- Sec. 8414.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
- 25 district may issue, without an election, bonds and other
- 26 obligations secured by revenue other than ad valorem taxes.
- 27 (b) The district must hold an election in the manner

- 1 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 2 before the district may impose an ad valorem tax or issue bonds
- 3 payable from ad valorem taxes.
- 4 (c) The district may not issue bonds payable from ad valorem
- 5 taxes to finance a road project unless the issuance is approved by a
- 6 vote of a two-thirds majority of the district voters voting at an
- 7 <u>election held for that purpose.</u>
- 8 Sec. 8414.152. OPERATION AND MAINTENANCE TAX. (a) If
- 9 authorized at an election held under Section 8414.151, the district
- 10 may impose an operation and maintenance tax on taxable property in
- 11 the district in accordance with Section 49.107, Water Code.
- 12 (b) The board shall determine the tax rate. The rate may not
- 13 exceed the rate approved at the election.
- 14 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- 15 Sec. 8414.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 16 OBLIGATIONS. The district may issue bonds or other obligations

- 25 or part of the bonds are outstanding as required and in the manner
- 26 provided by Sections 54.601 and 54.602, Water Code.
- Sec. 8414.203. BONDS FOR ROAD PROJECTS. At the time of

- 1 <u>issuance</u>, the total principal amount of bonds or other obligations
- 2 <u>issued or incurred to finance road projects and payable from ad</u>
- 3 valorem taxes may not exceed one-fourth of the assessed value of the
