8	board of trustees by rule shall ensure that employees receive
9	information about life coverage, accidental death and
10	dismemberment coverage, and long-term and short-term loss of salary
11	coverage, if those coverages are included in a group coverage plan
12	established under Section 1551.201.
13	(b) The information must contain descriptions of:
14	(1) probabilities of death and disability; and
15	(2) policy exclusions and limitations, including:
16	(A) limitations based on multiple sources of
17	benefits;
18	(B) preexisting condition exclusions; and
19	(C) required waiting periods for benefits.
20	(c) The board of trustees by rule may provide the
21	information described by Subsections (a) and (b) in printed
22	materials for new employees distributed on the first day of
23	employment. The board of trustees may consider using printed
24	materials, online presentations, and educational presentations to

1 ensure the information described by Subsections (a) and (b) is
2 provided to employees.

3 (d) If applicable, the board of trustees shall annually 4 review the materials and presentations described by Subsection (c) 5 to determine if changes to the contents of the materials or 6 presentations are necessary. If applicable, the department shall 7 adopt rules necessary for considering and making changes to the 8 materials or presentations.

9 <u>(e) The board of trustees shall publish the information</u> 10 <u>described by Subsections (a) and (b) on the Employees Retirement</u> 11 <u>System of Texas website.</u>

12 SECTION 2. The board of trustees shall adopt rules to 13 implement the changes in law made by this Act not later than January 14 1, 2014.

15 SECTION 3. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2013.
