A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to an exemption for certain persons who sell signs from the
- 3 requirement to be licensed as an electrician.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1305.003(a), Occupations Code, is
- 6 amended to read as follows:
- 7 (a) This chapter does not apply to:
- 8 (1) the installation of electrical equipment in a
- 9 ship, watercraft other than a floating building, railway rolling
- 10 stock, aircraft, motor vehicle, or recreational vehicle;
- 11 (2) the installation of electrical equipment
- 12 underground in a mine and in self-propelled mobile surface mining
- 13 machinery and its attendant electrical trailing cable;
- 14 (3) the installation of electrical equipment for
- 15 generation, transformation, transmission, or distribution of power
- 16 used exclusively to operate railway rolling stock or exclusively
- 17 for signaling and communications purposes;
- 18 (4) the installation, maintenance, alteration, or
- 19 repair of communications equipment provided by a
- 20 telecommunications provider;
- 21 (5) the installation, maintenance, alteration, or
- 22 repair of electrical equipment under the exclusive control of an
- 23 electric utility, power generation company as defined by Sections
- 24 31.002(1) and (10), Utilities Code, electric cooperative, or

- 1 municipally owned utility and used for communications or metering,
- 2 or for the generation, control, transformation, transmission, and
- 3 distribution of electrical energy, and located:
- 4 (A) in a building used exclusively by a utility
- 5 or power generation company for those purposes;
- 6 (B) outdoors on property owned or leased by the
- 7 utility or power generation company;
- 8 (C) on public highways, streets, roads, or other
- 9 public rights-of-way; or
- 10 (D) outdoors by established rights in vaults or
- 11 on private property;
- 12 (6) work not specifically regulated by a municipal
- 13 ordinance that is performed in or on a dwelling by a person who owns
- 14 and resides in the dwelling;
- 15 (7) work involved in the manufacture of electrical
- 16 equipment that includes the on-site and off-site manufacturing,
- 17 commissioning, testing, calibrating, coordinating,
- 18 troubleshooting, or evaluating of electrical equipment, the
- 19 repairing or retrofitting of electrical equipment with components
- 20 of the same ampacity, and the maintenance and servicing of
- 21 electrical equipment within the equipment's enclosure that is
- 22 performed by an authorized employee or authorized representative of
- 23 an electrical equipment manufacturer and limited to the type of
- 24 products manufactured by the manufacturer;
- 25 (8) electrical work if:
- 26 (A) the work is performed by a person who does not
- 27 engage in electrical work for the public;

- 1 (B) the work is performed by a person regularly
- 2 employed as a maintenance person or maintenance electrician for a
- 3 business; and
- 4 (C) the electrical work does not involve the
- 5 installation of electrical equipment during new construction as
- 6 defined by rules adopted under Chapter 151, Tax Code;
- 7 (9) the installation, maintenance, alteration, or
- 8 repair of electrical equipment or associated wiring under the
- 9 exclusive control of a gas utility and used for communications or
- 10 metering or for the control, transmission, or distribution of
- 11 natural gas;
- 12 (10) thoroughfare lighting, traffic signals,
- 13 intelligent transportation systems, and telecommunications
- 14 controlled by a governmental entity;
- 15 (11) electrical connections supplying heating,
- 16 ventilation, and cooling and refrigeration equipment, including
- 17 any required disconnect exclusively for the equipment, if the
- 18 service is performed by a licensed air conditioning and
- 19 refrigeration contractor under Chapter 1302;
- 20 (12) the design, installation, erection, repair, or
- 21 alteration of Class 1, Class 2, or Class 3 remote control,
- 22 signaling, or power-limited circuits, fire alarm circuits, optical
- 23 fiber cables, or communications circuits, including raceways, as
- 24 defined by the National Electrical Code;
- 25 (13) landscape irrigation installers, as necessary to
- 26 perform the installation and maintenance of irrigation control
- 27 systems, and landscapers, as necessary to perform the installation

- 1 and maintenance of low-voltage exterior lighting and holiday
- 2 lighting excluding any required power source;
- 3 (14) electrical work performed at a business that
- 4 operates:
- 5 (A) a chemical plant, petrochemical plant,
- 6 refinery, natural gas plant, natural gas treating plant, pipeline,
- 7 or oil and gas exploration and production operation by a person who
- 8 works solely for and is employed by that business; or
- 9 (B) a chemical plant, petrochemical plant,
- 10 refinery, natural gas plant, or natural gas treatment plant by a
- 11 person who under a contract of at least 12 months' duration performs
- 12 electrical work for that plant and:
- 13 (i) the electrical work is not performed
- 14 during new construction as defined by rules adopted under Chapter
- 15 151, Tax Code; or
- 16 (ii) the person is not working for a
- 17 contractor that has a principal place of business in another state
- 18 or territory of the United States or a foreign country;
- 19 (15) the installation, maintenance, alteration, or
- 20 repair of elevators, escalators, or related equipment, excluding
- 21 any required power source, regulated under Chapter 754, Health and
- 22 Safety Code;
- 23 (16) the installation, maintenance, alteration, or
- 24 repair of equipment or network facilities provided or utilized by a
- 25 cable operator, as that term is defined by 47 U.S.C. Section 522, as
- 26 amended;
- 27 (17) the location, design, construction, extension,

- 1 maintenance, and installation of on-site sewage disposal systems in
- 2 accordance with Chapter 366, Health and Safety Code, or an on-site
- 3 sewage facility installer licensed under Chapter 37, Water Code;
- 4 (18) electrical work performed on a building,
- 5 structure, or equipment in agricultural use as defined by Section
- 6 11.002, Water Code, other than the processing of an agricultural
- 7 commodity;
- 8 (19) the installation, maintenance, alteration, or
- 9 repair of well pumps and equipment in accordance with Chapter 1902;
- 10 (20) electrical work required for the construction and
- 11 assembly of HUD-code manufactured housing or modular housing and
- 12 building units, other than the installation of service entrance
- 13 conductors, that is performed by a licensed manufacturer or
- 14 installer under Chapter 1201 or 1202, as applicable, if work
- 15 performed is within the scope of the license as defined by
- 16 applicable statutes and administrative rules;
- 17 (21) work performed by a plumber who holds a license or
- 18 endorsement or is registered under Chapter 1301 that is necessary
- 19 to install, service, maintain, repair, or replace any type of
- 20 plumbing fixture or appliance, as described by Section 1301.002(7),
- 21 including a water heater, food disposer, garbage disposal, water
- 22 softener, dishwashing machine, and clothes washing machine on
- 23 existing electrical circuits only;
- 24 (22) the maintenance or repair of a residential
- 25 appliance by a residential appliance dealer or manufacturer or a
- 26 person authorized by a residential appliance dealer or manufacturer
- 27 using only components of the same type and ampacity as the original

- 1 components; [and]
- 2 (23) the maintenance, alteration, or repair of a
- 3 pool-related electrical device by, or pool-related electrical
- 4 maintenance performed by, an employee of a municipality on a pool
- 5 owned or operated by the municipality; and
- 6 (24) a person who sells or offers to sell a sign that
- 7 requires electrical work or electrical sign work in connection with
- 8 the construction or installation of the sign if the person:
- 9 (A) does not perform or offer to perform that
- 10 electrical work or electrical sign work;
- 11 (B) uses only an electrical contractor under
- 12 Section 1305.159 or an electrical sign contractor under Section
- 13 1305.160 to perform that work; and
- 14 (C) includes on the final invoice for the sale of
- 15 the sign the name and license number of the electrical contractor or
- 16 <u>electrical sign contractor who performs the electrical work or</u>
- 17 electrical sign work.
- 18 SECTION 2. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2013.
