6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle F, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 8432 to read as follows:
9	CHAPTER 8432. NORTH SAN GABRIEL MUNICIPAL UTILITY DISTRICT OF
10	WILLIAMSON COUNTY
11	SUBCHAPTER A. GENERAL PROVISIONS
12	Sec. 8432.001. DEFINITIONS. In this chapter:
13	(1) "Board" means the district's board of directors.
14	(2) "Commission" means the Texas Commission on
15	Environmental Quality.
16	(3) "Director" means a board member.
17	(4) "District" means the North San Gabriel Municipal
18	Utility District of Williamson County.
19	Sec. 8432.002. NATURE OF DISTRICT. The district is a
20	municipal utility district created under Section 59, Article XVI,
21	Texas Constitution.
22	Sec. 8432.003. CONFIRMATION AND DIRECTORS' ELECTION
23	REQUIRED. The temporary directors shall hold an election to
24	confirm the creation of the district and to elect five permanent

1 directors as provided by Section 49.102, Water Code. 2 Sec. 8432.004. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) 3 The district is created to serve a public purpose and benefit. 4 (b) The district is created to accomplish the purposes of: (1) a municipal utility district as provided by 5 general law and Section 59, Article XVI, Texas Constitution; and 6 7 (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, 8 or maintenance of macadamized, graveled, or paved roads, or 9 10 improvements, including storm drainage, in aid of those roads. Sec. 8432.005. INITIAL DISTRICT TERRITORY. (a) The 11 12 district is initially composed of the territory described by Section 2 of the Act enacting this chapter. 13 14 (b) The boundaries and field notes contained in Section 2 of 15 the Act enacting this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 16 17 does not affect the district's: (1) organization, existence, or validity; 18 19 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 20 interest on a bond; 21 2.2 (3) right to impose a tax; or

- 2 SUBCHAPTER C. POWERS AND DUTIES
- 3 Sec. 8432.101. GENERAL POWERS AND DUTIES. The district has
- 4 the powers and duties necessary to accomplish the purposes for
- 5 which the district is created.
- 6 Sec. 8432.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 7 DUTIES. The district has the powers and duties provided by the
- 8 general law of this state, including Chapters 49 and 54, Water Code,
- 9 applicable to municipal utility districts created under Section 59,
- 10 Article XVI, Texas Constitution.
- 11 Sec. 8432.103. AUTHORITY FOR ROAD PROJECTS. Under Section
- 12 52, Article III, Texas Constitution, the district may design,
- 13 acquire, construct, finance, issue bonds for, improve, operate,
- 14 maintain, and convey to this state, a county, or a municipality for
- operation and maintenance macadamized, graveled, or paved roads, or
- 16 improvements, including storm drainage, in aid of those roads.
- 17 Sec. 8432.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road
- 18 project <u>must meet all applicable construction standards</u>, zoning and
- 19 subdivision requirements, and regulations of each municipality in
- 20 whose corporate limits or extraterritorial jurisdiction the road
- 21 project is located.
- (b) If a road project is not located in the corporate limits
- 23 or extraterritorial jurisdiction of a municipality, the road
- 24 project must meet all applicable construction standards,
- 25 subdivision requirements, and regulations of each county in which
- 26 the road project is located.
- (c) If the state will maintain and operate the road, the

- 1 Texas Transportation Commission must approve the plans and
- 2 specifications of the road project.
- 3 Sec. 8432.105. DIVISION OF DISTRICT. (a) The district may
- 4 <u>be divided into two or more new districts</u> only if the district:
- 5 (1) has no outstanding bonded debt; and
- 6 (2) is not imposing ad valorem taxes.
- 7 (b) This chapter applies to any new district created by the
- 8 division of the district, and a new district has all the powers and
- 9 duties of the district.
- 10 (c) Any new district created by the division of the district
- 11 may not, at the time the new district is created, contain any land
- 12 outside the area described by Section 2 of the Act creating this
- 13 chapter.
- 14 (d) The board, on its own motion or on receipt of a petition
- 15 <u>signed by the owner or owners of a majority of the assessed</u> value of
- 16 the real property in the district, may adopt an order dividing the
- 17 district.
- 18 (e) The board may adopt an order dividing the district
- 19 before or after the date the board holds an election under Section
- 20 8432.003 to confirm the district's creation.
- 21 <u>(f) An order dividing the district shall:</u>
- 22 <u>(1) name each new district;</u>
- 23 (2) include the metes and bounds of each new district;
- 24 (3) appoint temporary directors for each new district;
- 25 and
- 26 (4) provide for the division of assets and liabilities
- 27 between or among the new districts.

- SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- Sec. 8432.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
- 15 <u>district may issue</u>, without an election, bonds and other
- 16 <u>obligations secured by revenue other than ad valorem taxes.</u>
- 17 (b) The district must hold an election in the manner
- 18 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 19 before the district may impose an ad valorem tax or issue bonds
- 20 payable from ad valorem taxes.
- 21 (c) The district may not issue bonds payable from ad valorem
- 22 taxes to finance a road project unless the issuance is approved by a
- 23 vote of a two-thirds majority of the district voters voting at an
- 24 election held for that purpose.
- Sec. 8432.152. OPERATION AND MAINTENANCE TAX. (a) If
- 26 authorized at an election held under Section 8432.151, the district
- 27 may impose an operation and maintenance tax on taxable property in

- 1 the district in accordance with Section 49.107, Water Code.
- 2 (b) The board shall determine the tax rate. The rate may not
- 3 exceed the rate approved at the election.
- 4 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- 5 Sec. 8432.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 6 OBLIGATIONS. The district may issue bonds or other obligations
- 7 payable wholly or partly from ad valorem taxes, impact fees,
- 8 revenue, contract payments, tax increment payments, grants, or
- 9 other district money, or any combination of those sources, to pay
- 10 for any authorized district purpose.
- 11 Sec. 8432.202. TAXES FOR BONDS. At the time the district
- 12 issues bonds payable wholly or partly from ad valorem taxes, the
- 13 board shall provide for the annual imposition of a continuing
- 14 direct ad valorem tax, without limit as to rate or amount, while all
- or part of the bonds are outstanding as required and in the manner
- 16 provided by Sections 54.601 and 54.602, Water Code.
- 17 Sec. 8432.203. BONDS FOR ROAD PROJECTS. At the time of
- 18 issuance, the total principal amount of bonds or other obligations
- 19 issued or incurred to finance road projects and payable from ad
- 20 valorem taxes may not exceed one-fourth of the assessed value of the
- 21 real property in the district.
- 22 SECTION 2. The North San Gabriel Municipal Utility District
- 23 of Williamson County initially includes all the territory contained
