4	SECTION 1. Chapter 30, Civil Practice and Remedies Code, is
5	amended by adding Section 30.022 to read as follows:
6	Sec. 30.022. PROCESS SERVERS. (a) Notwithstanding the
7	Texas Rules of Civil Procedure and except as provided by Subsection
8	(b), any process in a suit, including citation and other notices,
9	writs, orders, and other papers issued by a court, may be served by
10	any individual who:
11	(1) is 18 years of age or older; and
12	(2) is not a party to the suit or interested in the
13	outcome of the suit.
14	(b) Unless otherwise authorized by written court order,
15	only a sheriff or constable may serve:
16	(1) a citation in an action of forcible entry and
17	detainer;
18	(2) a writ that requires the actual taking of
19	possession of a person, property, or thing; or
20	(3) a writ requiring that an enforcement action be
21	physically enforced by the person delivering the process.
22	SECTION 2. This Act applies to the service of process on or
23	after the effective date of this Act, without regard to whether the
24	suit commenced before, on, or after that date.

1 SECTION 3. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2013.
