- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter J, Chapter 2301, Occupations Code, is
- 6 amended by adding Section 2301.483 to read as follows:
- 7 Sec. 2301.483. SELECTION BY DEALER OF VENDOR OR MATERIALS
- 8 FOR DEALERSHIP IMPROVEMENT. (a) Except as otherwise provided by
- 9 this section, a manufacturer or distributor may not:
- 10 <u>(1) require a dealer to purchase or use specific</u>
- 11 materials or to purchase materials, goods, or services from a
- 12 specific vendor when making an upgrade or improvement to the
- 13 <u>dealer's dealership; or</u>
- 14 (2) directly or indirectly take an adverse action
- 15 against a dealer who chooses materials, goods, or services or a
- 16 vendor for an upgrade to the dealer's dealership as provided by this
- 17 section.
- 18 (b) If a manufacturer or distributor provides money,
- 19 <u>credit</u>, an allowance, or a reimbursement directly or indirectly to
- 20 <u>a dealer to compensate the dealer for the cost of, or a substantial</u>
- 21 portion of the cost of, a specific upgrade or improvement to the
- 22 <u>dealer's dealership</u>, the dealer may select the materials, goods,
- 23 <u>services</u>, and vendors for the upgrade or improvement, but shall
- 24 select materials, goods, services, and vendors that are of like

- 1 kind and quality to those specified by the manufacturer or
- 2 distributor, if any.
- 3 <u>(c) This section does not allow a dealer or a vendor</u>
- 4 selected by a dealer to infringe on, eliminate, or impair a
- 5 manufacturer's or distributor's intellectual property rights.
- 6 (d) This section does not apply to a sign that contains
- 7 intellectual property owned by a manufacturer or distributor.
- 8 SECTION 2. The changes in law made by this Act apply to a
- 9 manufacturer, distributor, and dealer regardless of the date the
- 10 person's license is issued or renewed under Chapter 2301,
- 11 Occupations Code, and regardless of the date a franchise agreement
- 12 is entered into or renewed.
- SECTION 3. This Act takes effect September 1, 2013.
