A BILL TO BE ENTITLED

1 AN ACT

2 relating to the regulation of speech-language pathology and

- 3 audiology and the fitting and dispensing of hearing instruments.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 401.057, Occupations Code, is amended to
- 6 read as follows:
- 7 Sec. 401.057. HEARING CONSERVATION PROGRAM. This chapter
- 8 does not prevent a person in an industrial setting from engaging in
- 9 hearing testing as a part of a hearing conservation program in
- 10 compliance with federal Occupational Safety and Health
- 11 Administration regulations [if the person is certified by an agency
- 12 acceptable to the Occupational Safety and Health Administration].
- SECTION 2. Subchapter E, Chapter 401, Occupations Code, is
- 14 amended by adding Section 401.2022 to read as follows:
- 15 Sec. 401.2022. JOINT RULES FOR FITTING AND DISPENSING OF
- 16 HEARING INSTRUMENTS BY TELEPRACTICE. With the assistance of the
- 17 department, the board and the State Committee of Examiners in the
- 18 Fitting and Dispensing of Hearing Instruments shall jointly adopt
- 19 rules to establish requirements for the fitting and dispensing of
- 20 hearing instruments by the use of telepractice.
- 21 SECTION 3. Section 401.304(a), Occupations Code, is amended
- 22 to read as follows:
- 23 (a) To be eligible for licensing as a speech-language
- 24 pathologist or audiologist, an applicant must:

- 1 (1) if the application is for a license in:
- 2 (A) speech-language pathology, possess at least
- 3 a master's degree with a major in at least one of the areas of
- 4 communicative sciences or disorders from a program accredited by a
- 5 national accrediting organization that is approved by the board and
- 6 recognized by the United States secretary of education under the
- 7 Higher Education Act of 1965 (20 U.S.C. Section 1001 et seq.) in an
- 8 accredited or approved college or university; or
- 9 (B) audiology, possess at least a doctoral degree
- 10 in audiology or a related hearing science from a program accredited
- 11 by a national accrediting organization that is approved by the
- 12 board and recognized by the United States secretary of education
- 13 under the Higher Education Act of 1965 (20 U.S.C. Section 1001 et
- 14 seq.) in an accredited or approved college or university;
- 15 (2) submit a transcript from a public or private
- 16 institution of higher learning showing successful completion of
- 17 course work in amounts set by the board in:
- 18 (A) normal development and use of speech,
- 19 language, and hearing;
- 20 (B) evaluation, habilitation, and rehabilitation
- 21 of speech, language, and hearing disorders; and
- (C) related fields that augment the work of
- 23 clinical practitioners of speech-language pathology and audiology;
- 24 (3) have successfully completed at least 36 semester
- 25 hours in courses that are acceptable toward a graduate degree by the
- 26 college or university in which the courses are taken, at least 24 of
- 27 which must be in the professional area for which the license is

- 1 requested [and at least six of which must be:
- 2 [(A) in audiology if the application is for a
- 3 speech-language pathology license; or
- 4 [(B) in speech-language pathology if the
- 5 application is for an audiology license];
- 6 (4) have completed the minimum number of hours,
- 7 established by the board, of supervised clinical experience with
- 8 persons who present a variety of communication disorders; and
- 9 (5) have completed the full-time supervised
- 10 professional experience, as defined by board rule, in which
- 11 clinical work has been accomplished in the major professional area
- 12 for which the license is being sought.
- SECTION 4. Section 401.306(a), Occupations Code, is amended
- 14 to read as follows:
- 15 (a) [The board shall notify each examinee of the results of
- 16 the examination not later than the 30th day after the date the
- 17 examination is administered. If an examination is graded or
- 18 reviewed by a national or state testing service that does not
- 19 directly notify examinees of the examination results, the board
- 20 shall notify each examinee of the results not later than the 14th
- 21 day after the date the board receives the results from the testing
- 22 service.
- SECTION 5. Subchapter G, Chapter 401, Occupations Code, is
- 24 amended by adding Section 401.315 to read as follows:
- 25 Sec. 401.315. LICENSING FOR MILITARY SPOUSES. (a) In this
- 26 section:
- 27 (1) "Military service member" means a person who is

- 1 currently serving in the armed forces of the United States, in a
- 2 reserve component of the armed forces of the United States,
- 3 <u>including the National Guard, or in the state military service of</u>
- 4 any state.
- 5 (2) "Military spouse" means a person who is married to
- 6 a military service member.
- 7 (b) The board shall issue a license to a military spouse
- 8 who:
- 9 (1) was licensed in good standing as a speech-language
- 10 pathologist or audiologist in another state as of the date of the
- 11 application;
- 12 (2) holds a master's degree in at least one of the
- 13 areas of communicative sciences or disorders from a program
- 14 accredited by a national accrediting organization that is:
- (A) approved by the board; and
- 16 (B) recognized by the United States secretary of
- 17 education under the Higher Education Act of 1965 (20 U.S.C. Section
- 18 1001 et seq.); and
- 19 (3) has not been the subject of a disciplinary action
- 20 in any jurisdiction in which the applicant is or has been licensed.
- 21 SECTION 6. Subchapter I, Chapter 401, Occupations Code, is
- 22 amended by adding Section 401.405 to read as follows:
- Sec. 401.405. TELEPRACTICE. (a) In this section,
- 24 "telepractice" means the use of telecommunications technology by a
- 25 <u>license holder for an assessment, intervention, or consultation</u>
- 26 regarding a speech-language pathology or audiology client.
- 27 (b) The board may adopt rules consistent with the joint

- 1 rules under Section 401.2022 to provide for the practice of
- 2 speech-language pathology or audiology by the use of telepractice
- 3 by a person licensed under this chapter, including rules that
- 4 establish the qualifications and duties of license holders who use
- 5 telepractice.
- 6 SECTION 7. Subchapter C, Chapter 402, Occupations Code, is
- 7 amended by adding Section 402.1023 to read as follows:
- 8 Sec. 402.1023. JOINT RULES FOR FITTING AND DISPENSING OF
- 9 HEARING INSTRUMENTS BY TELEPRACTICE. With the assistance of the
- 10 department, the committee and the State Board of Examiners for
- 11 Speech-Language Pathology and Audiology shall jointly adopt rules
- 12 to establish requirements for the fitting and dispensing of hearing
- 13 instruments by the use of telepractice.
- 14 SECTION 8. Subchapter H, Chapter 402, Occupations Code, is
- 15 amended by adding Section 402.354 to read as follows:
- Sec. 402.354. TELEPRACTICE. (a) In this section,
- 17 "telepractice" means the use of telecommunications technology by a
- 18 license holder for the fitting and dispensing of hearing
- 19 instruments.
- 20 (b) The committee may adopt rules consistent with the joint
- 21 rules under Section 402.1023 to provide for the fitting and
- 22 dispensing of hearing instruments by the use of telepractice,
- 23 including rules that establish the qualifications and duties of
- 24 license holders who use telepractice.
- 25 SECTION 9. The following provisions of the Occupations Code
- 26 are repealed:
- 27 (1) Section 401.309;

- 1 (2) Section 401.314; and
- 2 (3) Section 401.355(c).
- 3 SECTION 10. The State Board of Examiners for
- 4 Speech-Language Pathology and Audiology by rule may establish a
- 5 procedure to issue an audiologist license to a person who submits an
- 6 application before September 1, 2014, and who:
- 7 (1) has a master's degree in audiology; and
- 8 (2) was licensed as an audiologist in this state
- 9 between September 1, 2007, and September 1, 2011.
- SECTION 11. Section 401.304, Occupations Code, as amended
- 11 by this Act, applies only to an application for a license filed on
- 12 or after January 1, 2015. An application for a license filed before
- 13 January 1, 2015, is governed by the law in effect on the date the
- 14 application was filed, and that law is continued in effect for that
- 15 purpose.
- 16 SECTION 12. (a) The State Board of Examiners for
- 17 Speech-Language Pathology and Audiology and the State Committee of
- 18 Examiners in the Fitting and Dispensing of Hearing Instruments
- 19 shall jointly adopt rules under Sections 401.2022 and 402.1023,
- 20 Occupations Code, as added by this Act, not later than January 1,
- 21 2014.
- 22 (b) The State Board of Examiners for Speech-Language
- 23 Pathology and Audiology shall adopt any rules necessary to
- 24 implement Section 401.304, Occupations Code, as amended by this
- 25 Act, and Section 401.405, Occupations Code, as added by this Act,
- 26 not later than January 1, 2014.
- 27 (c) The State Committee of Examiners in the Fitting and

- 1 Dispensing of Hearing Instruments shall adopt any rules necessary
- 2 to implement Section 402.354, Occupations Code, as added by this
- 3 Act, not later than January 1, 2014.
- 4 SECTION 13. This Act takes effect September 1, 2013.
