No. 1581 1 address if the venturer or partner is not an individual; 2 (C) an estate: 3 (i) the name of the estate; 4 (ii) the estate's office address, if any; 5 (iii) the full name of each representative 6 of the estate; and 7 (iv) each representative's residence 8 address if the representative is an individual or the representative's office address if the representative is not an 9 individual; 10 (D) a real estate investment trust: 11 (i) the name of the trust; 12 (ii) the address of the trust; 13 14 (iii) the full name of each trustee 15 manager; and 16 (iv) each trustee manager's residence 17 address if the trustee manager is an individual or the trustee manager's office address if the trustee manager 18 is not an individual; or 19 20 (E) a company, other than а real estate 21 investment trust: 22 (i) the name of the company; 23 (ii) the state, country, or other 24 jurisdiction under the laws of which the company was organized; and 25 (iii) the company's office address; the period, not to exceed 10 years, during which 26 (3) 27 the registrant will use the assumed name; and

1 (4) a statement specifying that the business that is or will be conducted or the professional service that is or will be 2 3 rendered in the county under the assumed name is being or will be conducted or rendered as a proprietorship, sole practitioner, 4 partnership, real estate investment trust, joint-stock company, or 5 other form of unincorporated business or professional association 6 7 or entity other than a limited partnership, limited liability 8 company, limited liability partnership, or foreign filing entity. 9 SECTION 2. Subchapter B, Chapter 71, Business & Commerce

10 Code, is amended by adding Section 71.0531 to read as follows:

11 <u>Sec. 71.0531. CHANGE BY REGISTRANT TO AGENT FOR SERVICE OF</u> 12 <u>PROCESS. If a registrant changes the registrant's agent for</u> 13 <u>service of process included in the certificate filed under this</u> 14 <u>subchapter, the registrant shall file a statement of the change in</u> 15 <u>the office of the county clerk in each county in which the</u> 16 <u>registrant filed the certificate.</u>
