H.B. No. 1675

A BILL TO BE ENTITLED

AN ACT

relating to governmental entities subject to the sunset review process.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE 1. ENTITIES GIVEN 2021 SUNSET DATE

SECTION 1.01. TEXAS INVASIVE SPECIES COORDINATING COMMITTEE. Section 776.007(a), Government Code, is amended to read as follows:

(a) The committee is subject to Chapter 325 (Texas Sunset Act). ~~[The committee shall be reviewed during the periods in which the State Soil and Water Conservation Board is reviewed.]~~ Unless continued in existence as provided by that chapter, the committee is abolished and this chapter expires September 1, 2021 ~~[on the date on which that agency is subject to abolishment]~~.

SECTION 1.02. TEXAS COUNCIL ON PURCHASING FROM PEOPLE WITH DISABILITIES. Section 122.006, Human Resources Code, is amended to read as follows:

Sec. 122.006. SUNSET PROVISION. The Texas Council on Purchasing from People with Disabilities is subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the council is abolished and this chapter expires September 1, 2021 ~~[2015]~~.

ARTICLE 2. ENTITIES REMOVED FROM SPECIFIC SUNSET REVIEW

SECTION 2.01. EARLY CHILDHOOD HEALTH AND NUTRITION

1 INTERAGENCY COUNCIL. Section 116.002, Health and Safety Code, is  
2 amended to read as follows:

11                                   ARTICLE 3. EFFECTIVE DATE

12       SECTION 3.01. EFFECTIVE DATE. This Act takes effect  
13 immediately if it receives a vote of two-thirds of all the members  
14 elected to each house, as provided by Section 39, Article III, Texas  
15 Constitution. If this Act does not receive the vote necessary for  
16 immediate effect, this Act takes effect September 1, 2013.
