

AN ACT

relating to the official name of The University of Texas Southwestern Medical Center.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 51.821(4), Education Code, is amended to read as follows:

(4) "Participating medical school" means each of the following entities:

(E) the medical school at Texas Tech University Health Sciences Center at Lubbock;

(F) the medical school at Texas Tech University Health Sciences Center at El Paso;

(G) the Baylor College of Medicine;

(H) the college of osteopathic medicine at the University of North Texas Health Science Center at Fort Worth; and

(I) the medical school at The Texas A&M

1 University System Health Science Center.

2 SECTION 2. Section 55.1722(a), Education Code, is amended  
3 to read as follows:

4 (a) In addition to the other authority granted by this  
5 subchapter, the board of regents of The University of Texas System  
6 may acquire, purchase, construct, improve, renovate, enlarge, or  
7 equip property, buildings, structures, facilities, roads, or  
8 related infrastructure for the following institutions to be  
9 financed by the issuance of bonds in accordance with this  
10 subchapter, including bonds issued in accordance with its  
11 systemwide revenue financing program and secured as provided by  
12 that program in aggregate principal amounts not to exceed the  
13 following amounts:

3 \$5,610,000 for integrated Mesa Building renovations and gymnasium  
4 renovations;

6 \$22,950,000 to construct a science building on the main campus;

7 (8) The University of Texas at Tyler, \$20,910,000 to  
8 construct an engineering, sciences, and technology building and  
9 make other physical plant improvements;

10 (9) The University of Texas Southwestern Medical  
11 Center [~~at Dallas~~], \$40 million for North Campus phase IV  
12 construction;

13 (10) The University of Texas Medical Branch at  
14 Galveston, \$20 million to renovate and expand research facilities;

15 (11) The University of Texas Health Science Center at  
16 Houston, \$19,550,000 to construct or purchase a classroom building  
17 that includes facilities for clinical teaching and clinical  
18 research;

22 facility at the Laredo Extension Campus for educational and  
23 administrative purposes;

26 learning laboratory in or near the city of Harlingen;

4 building.

5 SECTION 4. Section 55.1742(c), Education Code, is amended  
6 to read as follows:

7 (c) In addition to the other authority granted by this  
8 subchapter, the board of regents of The University of Texas System  
9 may acquire, purchase, construct, improve, renovate, enlarge, or  
10 equip property, buildings, structures, or other facilities,  
11 including roads and related infrastructure, for The University of  
12 Texas Southwestern Medical Center [~~at Dallas~~], to be used primarily  
13 to conduct biomedical research and to be financed by the issuance of  
14 bonds in accordance with this subchapter, including bonds issued in  
15 accordance with a systemwide revenue financing program and secured  
16 as provided by that program, in an aggregate principal amount not to  
17 exceed \$56 million.

18 SECTION 5. Section 55.1752(a), Education Code, is amended

15 Southwestern Medical Center at Dallas is changed to The University  
16 of Texas Southwestern Medical Center.

17 (b) A reference in law to The University of Texas  
18 Southwestern Medical Center at Dallas means The University of Texas  
19 Southwestern Medical Center.

20 (c) An appropriation for the use and benefit of The  
21 University of Texas Southwestern Medical Center at Dallas is  
22 available for the use and benefit of The University of Texas  
23 Southwestern Medical Center.

24 (d) The board of regents of The University of Texas System  
25 and The University of Texas Southwestern Medical Center at Dallas  
26 shall ensure that the change of the name made by this Act is  
27 implemented with as little unnecessary cost as possible. The

1 medical center shall, to the maximum extent practicable, use all  
2 stationery and other consumable supplies that are printed with the  
3 institution's former name and are in its possession on the  
4 effective date of this Act.

5 SECTION 18. This Act takes effect September 1, 2013.
