(a) 15 Southwestern Medical Center at Dallas is changed to The University of Texas Southwestern Medical Center. 16 17 (b) A reference in law to The University of Texas Southwestern Medical Center at Dallas means The University of Texas 18 Southwestern Medical Center. 19 An appropriation for the use and benefit of The 20 (C) 21 University of Texas Southwestern Medical Center at Dallas is 22 available for the use and benefit of The University of Texas 23 Southwestern Medical Center. 24 (d) The board of regents of The University of Texas System 25 and The University of Texas Southwestern Medical Center at Dallas 26 shall ensure that the change of the name made by this Act is 27 implemented with as little unnecessary cost as possible. The

1 medical center shall, to the maximum extent practicable, use all 2 stationery and other consumable supplies that are printed with the 3 institution's former name and are in its possession on the 4 effective date of this Act.

5 SECTION 18. This Act takes effect September 1, 2013.
