- 13 (7) Subchapter N, Chapter 1601, Occupations Code; and
- 14 (8) Subchapter L, Chapter 1602, Occupations Code.
- 15 SECTION 6. The repeal of an offense by this Act does not apply to an offense committed before the effective date of the 16 repeal. An offense committed before the effective date of the 17 repeal is governed by the law as it existed on the date the offense 18 was committed, and the former law is continued in effect for that 19 purpose. For purposes of this section, an offense was committed 20 before the effective date of the repeal if any element of the 21 22 offense occurred before that date.
- SECTION 7. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.
