6 (c) This section shall be interpreted to provide protection 7 relating to confidentiality and immunity and protection from 8 liability with at least the same scope and to at least the same 9 extent as described by federal law, including 47 U.S.C. Section 10 615a and 47 U.S.C. Section 1472.

SECTION 4. Section 771.061, Health and Safety Code, is amended to read as follows:

STATEWIDE CONFIDENTIALITY OF INFORMATION. 13 14 (a) Information that a service provider of communications 15 [telecommunications] service is required to furnish to a governmental entity, including a regional planning commission, 16 17 emergency communications district, or public safety answering point, in providing 9-1-1 service or that a service provider, third 18 party, or other entity voluntarily furnishes at the request of a 19 governmental entity in providing [computerized] 9-1-1 service is 20 21 confidential and is not available for public inspection. Information that is contained in an address database maintained by 22 a governmental entity or a third party used in providing 23 24 [computerized] 9-1-1 service is confidential and is not available for public inspection. (b) A person commits an offense if the person makes a

7 (c) A person commits an offense if the person knowingly 8 permits <u>an electronic communications device</u>, <u>including</u> a 9 telephone, under the person's control to be used by another person 10 in a manner described in Subsection (b).

15 SECTION 8. Sections 42.062(a), (b), and (d), Penal Code, 16 are amended to read as follows:

(a) An individual commits an offense if the individual knowingly prevents or interferes with another individual's ability to place an emergency [telephone] call or to request assistance, <u>including a request for assistance using an electronic</u> <u>communications device</u>, in an emergency from a law enforcement agency, medical facility, or other agency or entity the primary purpose of which is to provide for the safety of individuals.

(b) An individual commits an offense if the individual
recklessly renders unusable <u>an electronic communications device</u>,
<u>including</u> a telephone, that would otherwise be used by another
individual to place an emergency [telephone] call or to request

assistance in an emergency from a law enforcement agency, medical
 facility, or other agency or entity the primary purpose of which is
 to provide for the safety of individuals.

(d) In this section, "emergency" means a condition or
circumstance in which any individual is or is reasonably believed
by the individual making a [telephone] call or requesting
<u>assistance</u> to be in fear of imminent assault or in which property is
or is reasonably believed by the individual making the [telephone]
call or requesting assistance to be in imminent danger of damage or
destruction.

SECTION 12. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. For purposes of this section, an offense was committed before the effective date of this Act if any element of the offense occurred before that date.
