6 (b) Each taxing unit [all or part of the territory of which is located in the county] shall annually provide the information 7 8 described by Subsection (a) pertaining to the taxing unit to the county assessor-collector of each county in which all or part of the 9 unit's territory is located [annually] following the adoption of a 10 tax rate by the taxing unit for the current tax year. The chief 11 appraiser of the appraisal district established in the county may 12 assist the county assessor-collector in identifying the taxing 13 14 units required to provide information to the assessor-collector.

15 (e) <u>The county assessor-collector for each county shall</u> 16 <u>report the tax rate information described by Subsection (a) for the</u> 17 <u>current tax year to the comptroller.</u>

18 <u>(f)</u> The comptroller by rule shall prescribe the <u>time and</u> 19 manner in which the information described by this section is 20 required to be <u>reported and published</u> [presented].

21 SECTION 7. Section 140.006, Local Government Code, is 22 repealed.

SECTION 8. (a) The governing body of a school district or junior college district required to publish an annual financial statement under former Section 140.006, Local Government Code, shall publish an annual financial statement for the last fiscal year ending before the effective date of this Act for which the

1 district has not published an annual financial statement.

(b) Section 140.008, Local Government Code, as added by this
Act, applies only to an annual financial report for a fiscal year
ending on or after the effective date of this Act. An annual
financial report for a fiscal year ending before the effective date
of this Act is governed by the law in effect when the fiscal year
ended, and the former law is continued in effect for that purpose.
SECTION 9. This Act takes effect September 1, 2013.
