- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

the holder of a distiller's and rectifier's permit.

- 5 SECTION 1. Section 14.01(a), Alcoholic Beverage Code, is
- 6 amended to read as follows:
- 7 (a) The holder of a distiller's and rectifier's permit may:
- 8 (1) manufacture distilled spirits;
- 9 (2) rectify, purify, and refine distilled spirits and
- 10 wines;

- 11 (3) mix wines, distilled spirits, or other liquors;
- 12 (4) bottle, label, and package the permit holder's
- 13 finished products;
- 14 (5) sell the finished products in this state to
- 15 holders of wholesaler's permits and to qualified persons outside
- 16 the state;
- 17 (6) import distilled spirits, to be used only for
- 18 manufacturing or rectification purposes, from holders of
- 19 nonresident seller's permits; [and]
- 20 (7) dispense free distilled spirits for consumption on
- 21 the permitted premises under Section 14.04; and
- 22 (8) if located in a wet area, sell distilled spirits to
- 23 ultimate consumers under Section 14.04 or 14.05.
- SECTION 2. Section 14.04(a), Alcoholic Beverage Code, is

- 1 amended to read as follows:
- 2 (a) The holder of a distiller's and rectifier's permit may
- 3 conduct distilled spirits samplings on the permitted premises. The
- 4 permit holder may dispense free samples or collect a fee for the
- 5 sampling.
- 6 SECTION 3. Chapter 14, Alcoholic Beverage Code, is amended
- 7 by adding Section 14.05 to read as follows:
- 8 Sec. 14.05. SALES TO ULTIMATE CONSUMERS. (a) The holder of
- 9 a distiller's and rectifier's permit may sell to ultimate consumers
- 10 for consumption on the permitted premises distilled spirits
- 11 manufactured or rectified by the permit holder in an amount not to
- 12 exceed 3,000 gallons annually.
- 13 (b) The holder of a distiller's and rectifier's permit may
- 14 sell distilled spirits manufactured by the permit holder to
- 15 <u>ultimate consumers for off-premises consumption in unbroken</u>
- 16 packages containing not more than 750 milliliters of distilled
- 17 spirits for off-premises consumption in an amount not to exceed
- 18 3,500 gallons annually.
- 19 (c) The holder of a distiller's and rectifier's permit may
- 20 not under Subsection (b) sell more than two 750 milliliter bottles
- 21 of distilled spirits or the equivalent to the same consumer within a
- 22 <u>30-day period.</u>
- 23 (d) A sale under Subsection (b):
- 24 (1) may be made only to an individual who is physically
- 25 present at the permit holder's premises; and
- 26 (2) must be delivered to the purchaser in person
- 27 during the purchaser's visit.

- 1 (e) A person may not make a purchase under Subsection (b) as
- 2 an agent for another person.
- 3 (f) The permit holder must check a purchaser's
- 4 identification and keep records of purchases in a manner that
- 5 enables the permit holder to comply with this section.
- 6 (g) A bottle of distilled spirits sold on the permit
- 7 <u>holder's premises under Subsection (b) must bear a notice affixed</u>
- 8 to the bottle that:
- 9 (1) does not obscure the label approved by the Alcohol
- 10 and Tobacco Tax and Trade Bureau;
- 11 (2) states that the bottle is commemorative;
- 12 (3) states the month and year the bottle is sold; and
- 13 (4) is signed by an agent of the permit holder.
- 14 SECTION 4. Chapter 105, Alcoholic Beverage Code, is amended
- 15 by adding Section 105.081 to read as follows:
- Sec. 105.081. HOURS OF SALE AND CONSUMPTION: DISTILLERY.
- 17 (a) The holder of a distiller's and rectifier's permit may sell and
- 18 offer for sale distilled spirits for on-premises consumption and a
- 19 person may consume distilled spirits on the permitted premises
- 20 during the same hours mixed beverages may be sold and offered for
- 21 sale by a mixed beverage permit holder under Section 105.03(b).
- (b) The holder of a distiller's and rectifier's permit may
- 23 <u>sell, offer for sale, and deliver distilled spirits to ultimate</u>
- 24 consumers for off-premises consumption during the same hours as the
- 25 holder of a package store permit may sell, offer for sale, or
- 26 deliver distilled spirits to ultimate consumers for off-premises
- 27 consumption.

- 1 SECTION 5. Section 183.001(b)(1), Tax Code, is amended to
- 2 read as follows:
- 3 (1) "Permittee" means a mixed beverage permittee, a
- 4 private club registration permittee, a private club exemption
- 5 certificate permittee, a private club late hours permittee, a daily
- 6 temporary private club permittee, a private club registration
- 7 permittee holding a food and beverage certificate, a daily
- 8 temporary mixed beverage permittee, a mixed beverage late hours
- 9 permittee, a mixed beverage permittee holding a food and beverage
- 10 certificate, [or] a caterer permittee, or a distiller's and
- 11 rectifier's permittee.
- 12 SECTION 6. Sections 14.01(c) and 14.04(g), Alcoholic
- 13 Beverage Code, are repealed.
- 14 SECTION 7. This Act takes effect September 1, 2013.
