8	SECTION 1. Chapter 107A, Health and Safety Code, is amended
9	by adding Sections 107A.0021 and 107A.0022 and amending Section
10	107A.003 to read as follows:
11	Sec. 107A.0021. DUTIES OF CENTER; REPORT. (a) The center
12	shall:
13	(1) identify the social determinants and health
14	conditions in most need of high-impact response to address
15	disproportionality and disparities across health and human
16	services agencies;
17	(2) monitor the implementation of plans to address
18	health disparities across health and human services agencies;
19	(3) assist the Health and Human Services Commission
20	and any other relevant health and human services, education,
21	juvenile justice, child welfare, and mental health agencies in
22	developing cross-systems performance measures aligned with the
23	components of the Texas model for addressing disproportionality and
24	disparities in the education, juvenile justice, child welfare,

health, and mental health systems adopted under Section 2.003(b), 1 2 Human Resources Code; and 3 (4) implement the Texas model for addressing disproportionality and disparities in the education, juvenile 4 justice, child welfare, health, and mental health systems adopted 5 under Section 2.003(b), Human Resources Code. 6 7 (b) Not later than July 1 of each year, the center shall submit a report to the executive commissioner of the Health and 8 Human Services Commission detailing the center's findings and 9 activities under Subsections (a)(1) and (2). 10 Sec. 107A.0022. CULTURAL AWARENESS. The center shall: 11 12 (1) advise each health and human services, education, juvenile justice, child welfare, and mental health agency on the 13 14 implementation and delivery of cultural competency training to all 15 service delivery staff, including persons providing service delivery under a single source continuum contract; and 16 17 (2) develop collaborative partnerships with community groups, agencies, faith-based organizations, and other community 18 organizations to support the delivery of culturally competent 19 services to children and families of every race and ethnicity. 20 Sec. 107A.003. FUNDING. The Health and Human Services 21 Commission may distribute to the center unobligated and unexpended 22 23 appropriations to be used to carry out its powers and perform its

24 duties.

25 SECTION 2. Section 2.002, Human Resources Code, is amended 26 by amending Subsection (a) and adding Subsection (f) to read as 27 follows:

The council consists of: 1 (a) 2 (1)one representative from each of the following 3 agencies appointed by the executive director, director, or commissioner of each agency: 4 5 (A) the Texas Education Agency; 6 (B) the Center for Elimination of Disproportionality and Disparities within the Health and Human 7 8 Services Commission; Assistive 9 (C) the Department of and Rehabilitative Services; 10 11 (D) the Department of Aging and Disability 12 Services; the Department of State Health Services; 13 (E) 14 (F) the Department of Family and Protective 15 Services; 16 the Texas Juvenile Justice Department [Youth (G) 17 Commission; [(H) the Texas Juvenile Probation Commission]; 18 19 (H) [(I)] the Health and Human Services Commission; and 20 (I) [(J)] the Office of Court Administration of 21 the Texas Judicial System; 22 one representative of the office of the attorney 23 (2) 24 general appointed by the attorney general; 25 (3) one representative of the Permanent Judicial 26 Commission for Children, Youth and Families appointed by the chair of the commission; 27

5 SECTION 3. Sections 2.003, 2.005, and 2.008, Human 6 Resources Code, are amended to read as follows:

Sec. 2.003. COUNCIL DUTIES; TEXAS MODEL FOR ADDRESSING
DISPROPORTIONALITY AND DISPARITIES [IN PREPARATION OF REPORT]. (a)
The council's duties include:

10 (1) reviewing the delivery of public and private child 11 welfare, juvenile justice, and mental health services to evaluate 12 the disproportionate rates of use of the services by children who 13 are members of a racial or ethnic minority group;

14 (2) reviewing the delivery of public education 15 services to determine which of those services are delivered 16 disproportionately to children who are members of a racial or 17 ethnic minority group;

(3) reviewing federal, state, and local funds appropriated to address the disproportionate use of children's services by children who are members of a racial or ethnic minority group;

(4) reviewing current best practice standards
addressing the disproportionate use of children's services by
children who are members of a racial or ethnic minority group;

(5) examining the qualifications and training of
children's service providers and making recommendations for
training curriculum and other necessary changes;

1 (6) recommending methods to improve use of available 2 public and private funds to address the disproportionate use of 3 children's services by children who are members of a racial or 4 ethnic minority group;

5 (7) providing information concerning identified unmet 6 children's service needs and providing recommendations concerning 7 the development of resources to meet the identified needs;

8 (8) examining outcomes for children who are members of 9 a racial or ethnic minority group who have exited or will exit the 10 public and private child welfare, juvenile justice, mental health, 11 and education systems; and

(9) recommending administrative and legislative actions related to appropriate programs and services to reduce and eliminate disparities in the systems and improve the long-term outcomes for children who are members of a racial or ethnic minority group who are served by the systems[, and

17 [(10) preparing a report consisting of the council's 18 findings and recommendations and the presentation of an 19 implementation plan to address disproportionate representation of 20 children who are members of a racial or ethnic minority group in the 21 use of children's services].

(b) Based on its research and findings, the council shall develop and adopt a Texas model for addressing disproportionality and disparities in the education, juvenile justice, child welfare, health, and mental health systems to be implemented across the relevant state agencies.
Sec. 2.005. COUNCIL REPORT. Not later than December 1,

1 <u>2014</u> [2012], the council shall prepare and submit to the lieutenant 2 governor, the speaker of the house of representatives, and the 3 legislature a report containing:

4 (1) the <u>status of the implementation of the Texas</u> 5 <u>model for addressing disproportionality and disparities in the</u> 6 <u>education, juvenile justice, child welfare, health, and mental</u> 7 <u>health systems adopted under Section 2.003(b);</u> [council's findings 8 and recommendations for addressing the disproportionate 9 representation of children who are members of a racial or ethnic 10 minority group in the use of children's services] and

11 (2) the council's recommendation as to whether to 12 continue the council.

13 Sec. 2.008. EXPIRATION OF CHAPTER. This chapter expires 14 December 1, 2015 [2013].

15 SECTION 4. Section 2.004(c), Human Resources Code, is 16 repealed.

17 SECTION 5. The Center for Elimination of Disproportionality 18 and Disparities within the Health and Human Services Commission is 19 not required to submit the initial report required under Section 20 107A.0021(b), Health and Safety Code, as added by this Act, before 21 July 1, 2014.

SECTION 6. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.
