- 8 (a) To promote the public safety, the commissioners court of a
- 9 county with a population of more than 1.3 million by order may
- 10 regulate the following in the unincorporated area of the county if
- 11 they occur on a public highway or road, in the right-of-way of a
- 12 public highway or road, or in a parking lot:
- 13 (1) the sale of items by a vendor of food or
- 14 merchandise, including live animals;
- 15 (2) the erection, maintenance, or placement of a
- 16 structure by a vendor of food or merchandise, including live
- 17 animals; and
- 18 (3) the solicitation of money.
- 19 (b) The commissioners court of a county with a population of
- 20 more than 700,000 and less than 800,000 that borders the United
- 21 Mexican States by order may regulate the activities described by
- 22 Subsection (a) in the manner described by that subsection, except
- 23 that:
- 24 (1) the regulation of activities on or in the

- 1 right-of-way of a public highway or road is limited to public
- 2 highways and roads with a speed limit of 40 miles per hour or
- 3 faster; and
- 4 (2) the county may not prohibit the sale of livestock.
- 5 (c) A county regulating vendors under Subsection (b) may
- 6 require that a vendor be located not closer to the edge of the
- 7 public highway or road than a distance that is equal to one-half the
- 8 width of the right-of-way adjacent to the highway or road.
- 9 SECTION 2. This Act takes effect immediately if it receives
- 10 a vote of two-thirds of all the members elected to each house, as
- 11 provided by Section 39, Article III, Texas Constitution. If this
- 12 Act does not receive the vote necessary for immediate effect, this
- 13 Act takes effect September 1, 2013.
