## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to maintenance and operation of travel information centers
- 3 by the Texas Department of Transportation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Effective September 1, 2013, Section 156.251(d),
- 6 Tax Code, is amended to read as follows:
- 7 (d) An amount equal to the amount of revenue derived from
- 8 the collection of taxes imposed by this chapter at a rate of
- 9 one-half of one percent shall be allocated in the general revenue
- 10 fund to be used for media advertising and other marketing
- 11 activities of the Texas Economic Development and Tourism Office and
- 12 for the operation of travel information centers by the Texas
- 13 Department of Transportation. Section 403.095 [Division of the
- 14 Texas Department of Commerce. Section 403.094(h)], Government
- 15 Code, does not apply to funds described in this section. [This
- 16 subsection takes effect October 1, 1994.
- 17 SECTION 2. Section 204.003, Transportation Code, is amended
- 18 to read as follows:
- 19 Sec. 204.003. TRAVEL INFORMATION CENTERS. (a) In this
- 20 section, "travel information center" means an information center
- 21 located at a principal gateway of this state that provides [The
- 22 department shall maintain and operate travel information centers at
- 23 the principal gateways to this state to provide] highway
- 24 information, travel guidance, and descriptive material designed to

- 1 assist the traveling public and stimulate travel to and within this
- 2 state.
- 3 (b) The department may:
- 4 (1) transfer to a local government the operation of a
- 5 travel information center located in the local government's
- 6 boundaries; or
- 7 (2) issue a request for proposals to private and
- 8 nonprofit entities for the operation of a travel information
- 9 center.
- 10 <u>(c) The department may maintain and operate the center as a</u>
- 11 rest area without staff if:
- 12 (1) a local government does not assume the operation
- of a travel information center under Subsection (b)(1); or
- 14 (2) the department finds none of the offers from its
- 15 request for proposals acceptable or is unable to comply with
- 16 federal law in issuing a contract under Subsection (b)(2).
- 17 (d) This section does not apply to a travel information
- 18 center located at the State Capitol.
- 19 SECTION 3. Section 204.004, Transportation Code, is amended
- 20 to read as follows:
- Sec. 204.004. PAYMENT OF COSTS. The department may pay from
- 22 highway revenues the cost, including the administration and
- 23 operation cost, of:
- 24 (1) developing, publishing, and distributing
- 25 material; [and]
- 26 (2) maintaining [and operating] travel information
- 27 centers; and

- 1 (3) maintaining and operating a travel information
- 2 center as an unstaffed rest area under Section 204.003(c).
- 3 SECTION 4. Section 204.009, Transportation Code, is amended
- 4 to read as follows:
- 5 Sec. 204.009. SALE OF PROMOTIONAL ITEMS AND COMMERCIAL
- 6 ADVERTISING SPACE. (a) The department may sell promotional items
- 7 such as calendars, books, prints, caps, light clothing, or other
- 8 items approved by the commission that advertise the resources of
- 9 this state.
- 10 (b) The department may sell commercial advertising space in
- 11 <u>a travel information center if the advertising is displayed solely</u>
- 12 within the travel information center and is not legible from the
- 13 highway.
- 14 (c) If the department sells commercial advertising space
- 15 under Subsection (b), the department shall set rates for commercial
- 16 advertising and other services available at a travel information
- 17 center at a level that generates receipts approximately sufficient
- 18 to cover the cost of its travel and information operations.
- 19 (d) All proceeds from the sale of the items and commercial
- 20 <u>advertising space</u> shall be deposited <u>in a separate account in [to</u>
- 21 the credit of] the state highway fund for the department's use in
- 22 its travel and information operations.
- (e) [<del>(c)</del>] Section 403.095, Government Code, does not apply
- 24 to money deposited under this section.
- 25 <u>(f) The department may not engage in any activities</u>
- 26 authorized under this section that would decrease the amount of
- 27 federal highway funding available to the department.

- 1 SECTION 5. Except as otherwise provided by this Act:
- 2 (1) this Act takes effect immediately if it receives a
- 3 vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution; and
- 5 (2) if this Act does not receive the vote necessary for
- 6 immediate effect, this Act takes effect September 1, 2013.
