## A BILL TO BE ENTITLED AN ACT

1-20 relating to eligibility of certain persons for enrollment in school district summer school courses. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-21 1-22

1-23 SECTION 1. Subchapter A, Chapter 25, Education Code, is 1-24 amended by adding Section 25.008 to read as follows:

Sec. 25.008. ENROLLMENT IN SUMMER SCHOOL COURSE BY PERSON 1-25 NOT ENROLLED IN DISTRICT. (a) Except as provided by Subsection (b), a school district shall permit a person who is eligible under Section 25.001 to attend school in the district but who is not 1-26 1-27 1-28 enrolled in school in the district to enroll in a district summer 1-29 school course on the same basis as a district student, including: 1-30

(1) 1-31 satisfaction eligibility of any course requirement; and (2) 1-32

1-33 payment of any fee authorized under Section 11.158 that is charged in connection with the course. 1-34

1-35 (b) Subsection (a) does not apply to enrollment in a program 1-36 under Section 29.088, 29.090, or 29.098 or in a similar intensive 1-37 program.

SECTION 2. This Act takes effect immediately if it receives 1-38 1-39 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this 1-40 Act does not receive the vote necessary for immediate effect, this 1-41 1-42 Act takes effect September 1, 2013.
