- SECTION 1. Subchapter D, Chapter 3905, Special District 5
- Local Laws Code, is amended by adding Section 3905.155 to read as
- follows: 7
- Sec. 3905.155. TAX INCREMENT FINANCING POWERS. (a) The 8
- 9 district may designate all or any part of the district as a tax
- increment reinvestment zone. The district may use tax increment 10
- financing under Chapter 311, Tax Code, in the manner provided by 11
- that chapter for a municipality, except as modified by this 12
- 13 section.
- 14 (b) The district has all powers provided under Chapter 311,
- Tax Code. 15
- 16 (c) The district and an overlapping taxing unit may enter
- into an interlocal agreement for the payment of all or a portion of 17
- the tax increment of the unit to the district. 18
- 19 (d) For the purpose of tax increment financing under this
- section, the board functions as the board of directors of the 20
- reinvestment zone. Section 311.009, Tax Code, does not apply to the 21

- 23 SECTION 2. (a) The legal notice of the intention to

- 2 copy of this Act have been furnished to all persons, agencies,
- 3 officials, or entities to which they are required to be furnished
- 4 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 5 Government Code.
- 6 (b) The governor, one of the required recipients, has
- 7 submitted the notice and Act to the Texas Commission on
- 8 Environmental Quality.
- 9 (c) The Texas Commission on Environmental Quality has filed
- 10 its recommendations relating to this Act with the governor, the
- 11 lieutenant governor, and the speaker of the house of
- 12 representatives within the required time.
- 13 (d) All requirements of the constitution and laws of this
- 14 state and the rules and procedures of the legislature with respect
- 15 to the notice, introduction, and passage of this Act are fulfilled
- 16 and accomplished.
- 17 SECTION 3. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2013.
