A BILL TO BE ENTITLED

	AN ACT

- 2 relating to the regulation of backflow prevention assembly testers
- 3 by the Texas State Board of Plumbing Examiners; authorizing a fee.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 1301, Occupations Code, is
- 6 amended by adding Section 1301.059 to read as follows:
- 7 Sec. 1301.059. BACKFLOW PREVENTION ASSEMBLY NOT EXEMPT.
- 8 The exemptions under this subchapter do not apply to an activity for
- 9 which a person is required to hold a backflow prevention assembly
- 10 <u>testing certificate.</u>
- 11 SECTION 2. The heading to Section 1301.351, Occupations
- 12 Code, is amended to read as follows:
- 13 Sec. 1301.351. LICENSE, ENDORSEMENT, [OR] REGISTRATION, OR
- 14 CERTIFICATE REQUIRED.
- SECTION 3. Section 1301.351, Occupations Code, is amended
- 16 by amending Subsections (a) and (a-2) and adding Subsections (e)
- 17 and (f) to read as follows:
- 18 (a) Except as provided by Subsection (f), a [A] person,
- 19 other than a responsible master plumber, may not engage in plumbing
- 20 unless:
- 21 (1) the person holds the proper license, registration,
- 22 or endorsement required by this chapter; and
- 23 (2) the person's work is supervised and controlled by a
- 24 person licensed under this chapter.

- 1 (a-2) Except as provided by Subsection (f), a [A] person
- 2 that advertises or otherwise offers to perform or provide plumbing
- 3 must secure the services of a responsible master plumber.
- 4 (e) Unless the person holds a certificate under Section
- 5 1301.360, a person may not:
- 6 (1) engage in the repair or testing of the
- 7 <u>installation or operation of a backflow prevention assembly; or</u>
- 8 (2) advertise and offer to perform or provide backflow
- 9 prevention assembly testing services as described by Subdivision
- 10 (1).
- 11 (f) A person who holds a certificate under Section 1301.360:
- 12 (1) is not required to have the person's work described
- 13 by Subsection (e)(1) supervised and controlled by a person licensed
- 14 under this chapter; and
- 15 (2) may advertise and offer to perform or provide
- 16 services as described by Subsection (e)(2).
- SECTION 4. Subchapter G, Chapter 1301, Occupations Code, is
- 18 amended by adding Section 1301.360 to read as follows:
- 19 Sec. 1301.360. BACKFLOW PREVENTION ASSEMBLY TESTING
- 20 CERTIFICATE. (a) The board shall issue a backflow prevention
- 21 <u>assembly testing certificate to an applicant who:</u>
- 22 (1) holds a high school diploma or its equivalent;
- (2) demonstrates at least two years of related work
- 24 experience as determined by the board;
- 25 (3) completes a training course approved by the board;
- 26 (4) passes an examination prescribed by the board;
- 27 (5) submits an application on a form prescribed by the

- 1 board; and
- 2 (6) pays the required fee.
- 3 (b) A certificate issued under this section expires on the
- 4 third anniversary of the date of issuance.
- 5 (c) Notwithstanding Subsection (a), the board shall issue a
- 6 backflow prevention assembly testing certificate to a person who
- 7 holds a current equivalent license, certificate, or registration
- 8 issued by another state if:
- 9 (1) the requirements to obtain the license,
- 10 certificate, or registration in the other state are substantially
- 11 equivalent to the requirements of Subsection (a), including the
- 12 examination requirement; and
- 13 (2) the license, certificate, or registration is
- 14 mandatory for the repair or testing of the installation or
- 15 operation of a backflow prevention assembly in the state in which
- 16 the license, certificate, or registration is issued.
- 17 SECTION 5. Section 1301.401(a), Occupations Code, is
- 18 amended to read as follows:
- 19 (a) Except as provided by Section 1301.360(b), a [A]
- 20 license, certificate, or registration under this chapter is valid
- 21 for one year. On payment of the required fee, a license,
- 22 certificate, or registration may be renewed for the appropriate
- 23 term [annually].
- SECTION 6. Sections 1301.404(a) and (b), Occupations Code,
- 25 are amended to read as follows:
- 26 (a) The board shall recognize, approve, and administer
- 27 continuing education programs for a person [persons] who holds a

- 1 <u>license</u>, <u>certificate</u>, [hold licenses] or <u>endorsement</u>
- 2 [endorsements] under this chapter.
- 3 (b) A person who holds a license, certificate, or
- 4 endorsement under this chapter must complete at least six hours of
- 5 continuing professional education each year the person holds the
- 6 license, certificate, or endorsement to renew the person's license,
- 7 certificate, or endorsement. Three of the six hours must be in the
- 8 subjects of health protection, energy conservation, and water
- 9 conservation.
- SECTION 7. Subchapter C, Chapter 341, Health and Safety
- 11 Code, is amended by adding Section 341.0345 to read as follows:
- 12 Sec. 341.0345. CERTIFICATION OF BACKFLOW PREVENTION
- 13 ASSEMBLY TESTERS. A person who repairs or tests the installation or
- 14 operation of backflow prevention assemblies must hold a certificate
- 15 <u>issued by the Texas State Board of Plumbing Examiners under Section</u>
- 16 <u>1301.360</u>, Occupations Code.
- SECTION 8. Section 341.034(c), Health and Safety Code, is
- 18 repealed.
- 19 SECTION 9. (a) Not later than November 1, 2013, the Texas
- 20 State Board of Plumbing Examiners shall adopt rules necessary to
- 21 implement the changes in law made by this Act, including any
- 22 amendments to rules described by Section 10(b) of this Act.
- 23 (b) Not later than January 1, 2014, the Texas State Board of
- 24 Plumbing Examiners shall begin accepting applications for and
- 25 issuing backflow prevention assembly testing certificates under
- 26 Section 1301.360, Occupations Code, as added by this Act.
- 27 SECTION 10. (a) On January 1, 2014, the following are

- 1 transferred to the Texas State Board of Plumbing Examiners:
- 2 (1) all powers, duties, obligations, and liabilities
- 3 of the Texas Commission on Environmental Quality relating to the
- 4 licensing of backflow prevention assembly testers; and
- 5 (2) all files and other records of the Texas
- 6 Commission on Environmental Quality kept by the commission
- 7 regarding backflow prevention assembly tester licenses.
- 8 (b) A rule adopted by the Texas Commission on Environmental
- 9 Quality that is in effect immediately before January 1, 2014, and
- 10 that relates to backflow prevention assembly tester licenses is, on
- 11 January 1, 2014, a rule of the Texas State Board of Plumbing
- 12 Examiners and remains in effect until amended or repealed by the
- 13 Texas State Board of Plumbing Examiners.
- 14 (c) In the period beginning on the effective date of this
- 15 Act and ending on January 1, 2014, the Texas Commission on
- 16 Environmental Quality shall continue to perform functions and
- 17 activities under Section 341.034(c), Health and Safety Code, as if
- 18 that subsection had not been repealed by this Act, and the former
- 19 law is continued in effect for that purpose.
- 20 (d) A person who holds a backflow prevention assembly tester
- 21 license issued by the Texas Commission on Environmental Quality
- 22 that is in effect on the effective date of this Act holds a backflow
- 23 prevention assembly testing certificate under Section 1301.360,
- 24 Occupations Code, as added by this Act, that expires on the
- 25 expiration date of the license.
- SECTION 11. (a) Except as provided by Subsection (b) of
- 27 this section, this Act takes effect September 1, 2013.

- 1 (b) Section 1301.351(e), Occupations Code, as added by this
- 2 Act, and the repeal by this Act of Section 341.034(c), Health and
- 3 Safety Code, take effect January 1, 2014.
