## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the qualifications of the chief appraiser of an
- 3 appraisal district; creating an offense.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1151.1581, Occupations Code, is amended
- 6 by adding Subsection (f) to read as follows:
- 7 (f) As part of the continuing education requirements for a
- 8 registered professional appraiser who is the chief appraiser of an
- 9 appraisal district, the commission by rule shall require the
- 10 registrant to complete:
- 11 (1) at least half of the required hours in a program
- 12 devoted to one or more of the topics listed in Section 1151.164(b);
- 13 and
- 14 (2) at least two of the required hours in a program of
- 15 professional ethics specific to the chief appraiser of an appraisal
- 16 district, including a program on the importance of maintaining the
- 17 independence of an appraisal office from political pressure.
- SECTION 2. Subchapter F, Chapter 1151, Occupations Code, is
- 19 amended by adding Section 1151.254 to read as follows:
- Sec. 1151.254. PROHIBITED ACTIONS OF CHIEF APPRAISER. (a)
- 21 A person who is appointed or serves as the chief appraiser of an
- 22 <u>appraisal district who is not certified as a registered</u>
- 23 professional appraiser under this chapter commits an offense if the
- 24 person performs an action authorized or required by law to be

- 1 performed by a chief appraiser of an appraisal district.
- 2 (b) An offense under this section is a Class A misdemeanor.
- 3 SECTION 3. Sections 6.05(c) and (d), Tax Code, are amended 4 to read as follows:
- 5 The chief appraiser is the chief administrator of the (c) appraisal office. Except as provided by Section 6.0501, the [The] 6 chief appraiser is appointed by and serves at the pleasure of the 7 8 appraisal district board of directors. If a taxing unit performs the duties of the appraisal office pursuant to a contract, the 9 10 assessor for the unit is the chief appraiser. To be eligible to be appointed or serve as a chief appraiser, a person must be certified 11 as a registered professional appraiser under Section 1151.160, 12 Occupations Code. A chief appraiser who is not eligible to be 13 appointed or serve as chief appraiser may not perform an action 14 15 authorized or required by law to be performed by a chief appraiser, including the preparation, certification, or submission of any part 16 17 of the appraisal roll.
- Except as provided by Section 6.0501, the [The] chief 18 19 appraiser is entitled to compensation as provided by the budget adopted by the board of directors. The chief appraiser's 20 compensation may not be directly or indirectly linked to an 21 increase in the total market, appraised, or taxable value of 22 property in the appraisal district. Except as provided by Section 23 24 6.0501, the [The] chief appraiser may employ and compensate professional, clerical, and other personnel as provided by the 25 26 budget, with the exception of a general counsel to the appraisal 27 district.

- 1 SECTION 4. Subchapter A, Chapter 6, Tax Code, is amended by
- 2 adding Section 6.0501 to read as follows:
- 3 Sec. 6.0501. APPOINTMENT OF ELIGIBLE CHIEF APPRAISER BY
- 4 COMPTROLLER. (a) The comptroller shall appoint a person eligible
- 5 to be a chief appraiser under Section 6.05(c) to perform the duties
- 6 of chief appraiser for an appraisal district whose chief appraiser
- 7 is ineligible to serve.
- 8 (b) A chief appraiser appointed under this section serves
- 9 until the earlier of:
- 10 (1) the first anniversary of the date the comptroller
- 11 appoints the chief appraiser; or
- 12 (2) the date the board of directors of the appraisal
- 13 district:
- 14 (A) appoints a chief appraiser under Section
- 15 <u>6.05(c); or</u>
- (B) contracts with a taxing unit to perform the
- 17 duties of the appraisal office for the district under Section
- 18 6.05(b).
- 19 (c) The comptroller shall determine the compensation of a
- 20 chief appraiser appointed under this section. A chief appraiser
- 21 appointed under this section shall determine the budget necessary
- 22 for the adequate operation of the appraisal office, subject to the
- 23 approval of the comptroller. The board of directors of the
- 24 appraisal district shall amend the budget as necessary to
- 25 compensate the appointed chief appraiser and fund the appraisal
- 26 office as determined under this subsection.
- 27 (d) An appraisal district that does not appoint a chief

- 1 appraiser or contract with an appraisal district to perform the
- 2 duties of the appraisal office by the first anniversary of the date
- 3 that the comptroller appoints a chief appraiser shall contract with
- 4 an appraisal district to perform the duties of the appraisal office
- 5 or with a qualified public or private entity to perform the duties
- 6 of the chief appraiser, subject to the approval of the comptroller.
- 7 SECTION 5. The Texas Commission of Licensing and Regulation
- 8 shall adopt the rules required by Section 1151.1581(f), Occupations
- 9 Code, as added by this Act, not later than January 1, 2014.
- 10 SECTION 6. A person appointed or serving as a chief
- 11 appraiser in an appraisal district established in a county with a
- 12 population of 100,000 or less on the effective date of this Act who
- 13 is not certified as a registered professional appraiser under
- 14 Chapter 1151, Occupations Code, but who is registered with the
- 15 Texas Department of Licensing and Regulation and classified as a
- 16 Class III appraiser under the rules of the Texas Commission of
- 17 Licensing and Regulation may continue to serve as the chief
- 18 appraiser until January 1, 2016.
- 19 SECTION 7. This Act takes effect January 1, 2014.
