adding Subsections (d-1), (e-1), and (h-1) and amending Subsection 4 5 (i) to read as follows: (d-1) Notwithstanding any other provision of this chapter, 6 7 a person who is convicted of and has satisfied the judgment for or 8 who has received a dismissal after deferral of disposition for a fine-only misdemeanor, other than a traffic offense or an offense 9 10 under a municipal ordinance or county order, may petition the court that convicted or granted a dismissal to the person for an order of 11 12 nondisclosure under this subsection. Subject to Subsection (e-1), a person may petition the court under this subsection regardless of 13 whether the person has been previously convicted of or granted a 14 dismissal for a fine-only misdemeanor offense. After notice to the 15 state and a hearing on whether the person is entitled to file the 16 petition and issuance of the order is in the best interest of 17 justice, the court shall issue an order prohibiting criminal 18 19 justice agencies from disclosing to the public criminal history record information related to the fine-only misdemeanor offense 20 that is the subject of the petition. As a condition of granting the 21 petition under this subsection for a person convicted of the 22 offense, a court may require the defendant to perform community 23 service, pay a fee, or both perform the community service and pay 24 the fee as if the defendant had been put on probation pending 25 26 deferred disposition under Article 45.051, Code of Criminal

Procedure. A criminal justice agency may disclose criminal history

- 2 under this subsection only to other criminal justice agencies, for
- 3 criminal justice or regulatory licensing purposes, an agency or
- 4 entity listed in Subsection (i), or the person who is the subject of
