1 AN ACT 2 relating to the name of Texas State University--San Marcos. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. The heading to Subchapter C, Chapter 96, 5 Education Code, is amended to read as follows: 6 SUBCHAPTER C. TEXAS STATE UNIVERSITY [--SAN MARCOS] 7 SECTION 2. Section 96.41, Education Code, is amended to read as follows: 8 TEXAS STATE UNIVERSITY[--SAN MARCOS]. 9 Sec. 96.41. Texas 10 State University [--San Marcos] is a coeducational institution of higher education located in the city of San Marcos with a campus 11 12 located in the city of Round Rock. The university [It] is under the management and control of the Board of Regents, Texas State 13 14 University System. SECTION 3. Section 54.511(a), Education Code, is amended to 15 read as follows: 16 (a) The board of regents of the Texas State University 17 System may charge each student enrolled at Texas 18 State University [--San Marcos] a fee initially set at \$10 per semester or 19 20 \$5 per six-week summer term to be used to finance bus service for 21 students attending the institution. 22 SECTION 4. Section 54.5381(a), Education Code, is amended 23 to read as follows:

SECTION 9. Section 55.1754(a), Education Code, is amended to read as follows:

In addition to the other authority granted by this 19 (a) subchapter, the board of regents of the Texas State University 20 System may acquire, purchase, construct, improve, renovate, 21 enlarge, or equip facilities, including roads and related 22 23 infrastructure, for projects to be financed through the issuance of 24 bonds in accordance with this subchapter and in accordance with a systemwide revenue financing program adopted by the board for the 25 26 following institutions not to exceed the following aggregate principal amounts for the projects specified as follows: 27

9 SECTION 11. Section 62.021(a), Education Code, is amended 10 to read as follows:

In each state fiscal year beginning with the state 11 (a) 12 fiscal year ending August 31, 2011, an eligible institution is entitled to receive an amount allocated in accordance with this 13 14 section from the funds appropriated for that year by Section 17(a), 15 Article VII, Texas Constitution. The comptroller shall distribute funds allocated under this subsection only on presentation of a 16 17 claim and issuance of a warrant in accordance with Section 403.071, Government Code. An eligible institution may not present a claim 18 19 to be paid from any funds allocated under this subsection before the delivery of goods or services described in Section 17, Article VII, 20 Texas Constitution, except for the payment of principal or interest 21 on bonds or notes or for a payment for a book or other published 22 23 library material as authorized by Section 2155.386, Government 24 Code. The allocation of funds under this subsection is made in accordance with an equitable formula consisting of the following 25 26 elements: space deficit, facilities condition, institutional complexity, and a separate allocation for the Texas State Technical 27

Section 411.050, Government Code, is amended to read as follows: 11 Sec. 411.050. CRIME STATISTIC MAPPING. The department, in 12 conjunction with Texas State University[--San Marcos], 13 may 14 annually produce maps of the state that include information 15 regarding crime statistics correlated with the various regions of 16 the state. SECTION 13. (a) The name of Texas State University--San 17 Marcos is changed to Texas State University. 18 19 (b) A reference in law to Texas State University--San Marcos means Texas State University. 20 (c) An appropriation for the use and benefit of Texas State 21 University--San Marcos is available for the use and benefit of 22 23 Texas State University. 24 (d) The board of regents of the Texas State University 25 System and Texas State University--San Marcos shall ensure that the 26 change of the name made by this Act is implemented with as little unnecessary cost as possible. The university shall, to the maximum 27

extent practicable, use all stationery and other consumable
 supplies that are printed with the institution's former name and
 are in its possession on the effective date of this Act.

4 SECTION 14. This Act takes effect September 1, 2013.
