- 14 Coordinate X-2818441.82, Y-229874.83.
- 15 SECTION 2. The heading to Section 3151.051, Government
- 16 Code, is amended to read as follows:

- 19 SECTION 3. Subchapter B, Chapter 3151, Government Code, is

6	SECTION 4. Section 3151.053, Government Code, is amended to
7	read as follows:
8	Sec. 3151.053. CONFLICT WITH OTHER [LOCAL] REQUIREMENTS.
9	If a requirement of this chapter conflicts with a requirement
10	enacted by a municipality or with any other requirement under state
11	<u>law</u> , the stricter requirement prevails.
12	SECTION 5. This Act takes effect immediately if it receives
13	a vote of two-thirds of all the members elected to each house, as
14	provided by Section 39, Article III, Texas Constitution. If this
15	Act does not receive the vote necessary for immediate effect, this
16	Act takes effect September 1, 2013.
