BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 25.025(a), Tax Code, as amended by Chapters 348 (H.B. 3307) and 953 (H.B. 1046), Acts of the 82nd 6 Legislature, Regular Session, 2011, is reenacted and amended to 7 read as follows: 8 This section applies only to: 9 (a) (1) a current or former peace officer as defined by 10 11 Article 2.12, Code of Criminal Procedure; 12 (2) a county jailer as defined by Section 1701.001, 13 Occupations Code; 14 (3) an employee of the Texas Department of Criminal Justice; 15 (4) a commissioned security officer as defined by 16 Section 1702.002, Occupations Code; 17 (5) a victim of family violence as defined by Section 18 71.004, Family Code, if as a result of the act of family violence 19 against the victim, the actor is convicted of a felony or a Class A 20 21 misdemeanor; 22 (6) a federal judge, a state judge, or the spouse of a 23 federal judge or state judge; district 24 (7) a current or former employee of a

1 attorney, criminal district attorney, or county or municipal 2 attorney whose jurisdiction includes any criminal law or child 3 protective services matters;

4 (8) an officer or employee of a community supervision
5 and corrections department established under Chapter 76,
6 Government Code, who performs a duty described by Section 76.004(b)
7 of that code;

8 (9) a criminal investigator of the United States as 9 described by Article 2.122(a), Code of Criminal Procedure;

10 (10) a police officer or inspector of the United 11 States Federal Protective Service; [and]

12 (11) a current or former United States attorney or 13 assistant United States attorney and the spouse and child of the 14 attorney;

15 <u>(12)</u> [<del>(11)</del>] a current or former employee of the office 16 of the attorney general who is or was assigned to a division of that 17 office the duties of which involve law enforcement; and

18 <u>(13) a medical examiner or person who performs</u> 19 <u>forensic analysis or testing who is employed by this state or one or</u> 20 <u>more political subdivisions of this state</u>.

21 SECTION 2. To the extent of any conflict, this Act prevails 22 over another Act of the 83rd Legislature, Regular Session, 2013, 23 relating to nonsubstantive additions to and corrections in enacted 24 codes.

25 SECTION 3. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this
