- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 501.091, Transportation Code, is amended
- 7 by adding Subdivision (1-a) and amending Subdivision (17) to read
- 8 as follows:
- 9 (1-a) "Brokering" means arranging or offering to
- 10 arrange a transaction involving the sale of a salvage motor vehicle
- 11 or nonrepairable motor vehicle for a fee, commission, or other
- 12 <u>valuable consideration</u>.
- 13 (17) "Salvage vehicle dealer" means a person engaged
- 14 in this state in the business of acquiring, selling, repairing,
- 15 rebuilding, reconstructing, <u>brokering</u>, or otherwise dealing in
- 16 nonrepairable motor vehicles, salvage motor vehicles, or, if
- 17 incidental to a salvage motor vehicle dealer's primary business,
- 18 used automotive parts regardless of whether the person holds a
- 19 license [issued by the department] to engage in that business. The
- 20 term does not include an unlicensed person who:
- 21 (A) casually repairs, rebuilds, or reconstructs

- Sec. 2309.357. SURRENDER OF CERTAIN DOCUMENTS [OR LICENSE
- 26 PLATES]. (a) A used automotive parts recycler shall surrender to
- 27 the Texas Department of Motor Vehicles [Transportation] for

- 6 SECTION 14. Section 683.053, Transportation Code, is
- 7 repealed.
- 8 SECTION 15. The changes in law made by this Act apply only
- 9 to an offense committed on or after the effective date of this Act.
- 10 An offense committed before the effective date of this Act is
- 11 governed by the law in effect on the date the offense was committed,
- 12 and the former law is continued in effect for that purpose. For
- 13 purposes of this section, an offense was committed before the
- 14 effective date of this Act if any element of the offense occurred
- 15 before that date.
- 16 SECTION 16. This Act takes effect September 1, 2013.
