## A BILL TO BE ENTITLED

1 AN ACT

2 relating to discipline of public school students by school bus

- 3 drivers.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 37.001(a), Education Code, is amended to
- 6 read as follows:
- 7 (a) The board of trustees of an independent school district
- 8 shall, with the advice of its district-level committee established
- 9 under Subchapter F, Chapter 11, adopt a student code of conduct for
- 10 the district. The student code of conduct must be posted and
- 11 prominently displayed at each school campus or made available for
- 12 review at the office of the campus principal. In addition to
- 13 establishing standards for student conduct, the student code of
- 14 conduct must:
- 15 (1) specify the circumstances, in accordance with this
- 16 subchapter, under which a student may be removed from a classroom,
- 17 campus, [or] disciplinary alternative education program, or school
- 18 <u>bus</u>;
- 19 (2) specify conditions that authorize or require a
- 20 principal or other appropriate administrator to transfer a student
- 21 to a disciplinary alternative education program;
- 22 (3) outline conditions under which a student may be
- 23 suspended as provided by Section 37.005 or expelled as provided by
- 24 Section 37.007;

- 1 (4) specify that consideration will be given, as a
- 2 factor in each decision concerning suspension, removal to a
- 3 disciplinary alternative education program, expulsion, or
- 4 placement in a juvenile justice alternative education program,
- 5 regardless of whether the decision concerns a mandatory or
- 6 discretionary action, to:
- 7 (A) self-defense;
- 8 (B) intent or lack of intent at the time the
- 9 student engaged in the conduct;
- 10 (C) a student's disciplinary history; or
- 11 (D) a disability that substantially impairs the
- 12 student's capacity to appreciate the wrongfulness of the student's
- 13 conduct;
- 14 (5) provide guidelines for setting the length of a
- 15 term of:
- 16 (A) a removal under Section 37.006; and
- 17 (B) an expulsion under Section 37.007;
- 18 (6) address the notification of a student's parent or
- 19 quardian of a violation of the student code of conduct committed by
- 20 the student that results in suspension, removal to a disciplinary
- 21 alternative education program, or expulsion;
- 22 (7) prohibit bullying, harassment, and making hit
- 23 lists and ensure that district employees enforce those
- 24 prohibitions; and
- 25 (8) provide, as appropriate for students at each grade
- 26 level, methods, including options, for:
- 27 (A) managing students in the classroom and on

- 1 school grounds;
- 2 (B) disciplining students; and
- 3 (C) preventing and intervening in student
- 4 discipline problems, including bullying, harassment, and making
- 5 hit lists.
- 6 SECTION 2. Subchapter A, Chapter 37, Education Code, is
- 7 amended by adding Section 37.0022 to read as follows:
- 8 Sec. 37.0022. REMOVAL BY SCHOOL BUS DRIVER. (a) The driver
- 9 of a school bus transporting students to or from school or a
- 10 school-sponsored or school-related activity may send a student to
- 11 the principal's office to maintain effective discipline on the
- 12 school bus. The principal shall respond by employing appropriate
- 13 <u>discipline management techniques consistent with the student code</u>
- 14 of conduct adopted under Section 37.001.
- 15 (b) The driver of a school bus transporting students to or
- 16 from school or a school-sponsored or school-related activity shall
- 17 send to the principal for placement in a disciplinary alternative
- 18 education program or for expulsion, as appropriate, a student who,
- 19 while on the school bus, engages in conduct described under Section
- 20 37.006 or 37.007.
- 21 SECTION 3. This Act applies beginning with the 2013-2014
- 22 school year.
- 23 SECTION 4. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect September 1, 2013.
