1 <u>college district and the political subdivision levying the tax, to</u> 2 <u>make lease payments to the political subdivision for facilities</u> 3 <u>used exclusively by the branch campus that are owned by the</u> 4 <u>political subdivision</u> [to operate, maintain, and support the same 5 <u>junior college district branch campus</u>].

6 SECTION 3. (a) The change in law made by this Act in adding 7 Section 130.0865, Education Code, applies only to a bond issued on 8 or after the effective date of this Act. A bond issued before the 9 effective date of this Act is governed by the law in effect at the 10 time the bond was issued, and the former law is continued in effect 11 for that purpose.

(b) The change in law made by this Act in amending Section 13 130.087, Education Code, applies to the proceeds of a junior 14 college district branch campus maintenance tax levied under Section 15 130.087, Education Code, without regard to whether imposition of 16 the tax was approved by the voters or the proceeds were derived from 17 taxes imposed before, on, or after the effective date of this Act.

18 SECTION 4. This Act takes effect immediately if it receives 19 a vote of two-thirds of all the members elected to each house, as 20 provided by Section 39, Article III, Texas Constitution. If this 21 Act does not receive the vote necessary for immediate effect, this 22 Act takes effect September 1, 2013.
