- 5 SECTION 1. Section 1101.005, Occupations Code, is amended

- 7 SUBCHAPTER N-1. BUILDING CONTRACTS AND TRANSFERS OF TITLE FROM
- 8 BUILDER
- 9 Sec. 1101.681. CONSTRUCTION DOCUMENTS. A builder who
- 10 constructs a new single-family home must provide a copy of any
- 11 documents used in the construction of the home, including written
- 12 <u>specifications or blueprints:</u>
- 13 <u>(1)</u> at the time the construction is completed, to the
- 14 person who contracted with the builder for the construction of the
- 15 home; or
- 16 (2) at the time title to the home is transferred by the
- 17 builder, to the person who purchases the home from the builder.
- 18 SECTION 4. The change in law made by this Act applies only
- 19 to a contract for construction entered into or a transfer of title
- 20 made on or after the effective date of this Act. A contract entered
- 21 into or a transfer of title made before the effective date of this
- 22 Act is governed by the law in effect immediately before the
- 23 effective date of this Act, and that law is continued in effect for
- 24 that purpose.
- 25 SECTION 5. This Act takes effect September 1, 2013.
