- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 452.541, Transportation Code, is amended
- 6 to read as follows:
- 7 Sec. 452.541. BOARD MEMBERSHIP: RESIDENCY IN AUTHORITY.
- 8 (a) Except as provided by Subsection (b), a [A] member of a
- 9 subregional board must be a qualified voter residing in the
- 10 authority.
- 11 (b) An individual who does not reside in the authority may
- 12 be appointed to the board under Section 452.562(c)(1) if the
- 13 individual is a qualified voter of and resides in a municipality
- 14 that:
- 15 (1) has entered into a contract with the authority to
- 16 receive services; and
- 17 (2) has adopted a sales tax to participate in the
- 18 funding of a transportation project being planned, developed, or
- 19 operated by the authority.
- SECTION 2. Section 452.562, Transportation Code, is amended
- 21 by amending Subsection (c) and adding Subsection (g) to read as
- 22 follows:
- (c) If Subsection (b) does not apply, the subregional board
- 24 shall be appointed as follows:

- 1 (1) the commissioners court of the county of the
- 2 principal municipality shall appoint at least one member to
- 3 represent:
- 4 (A) the unincorporated areas and municipalities
- 5 in the county that are not otherwise represented on the subregional
- 6 board; and
- 7 (B) the municipalities that have entered into a
- 8 contract with the authority to receive services; and
- 9 (2) the remaining members shall be apportioned to the
- 10 municipalities confirmed as all or part of the subregion according
- 11 to the ratio that the population of each unit of election bears to
- 12 the total population of the area confirmed as the subregion.
- 13 (g) An elected officer of the state or a political
- 14 subdivision of this state who is not prohibited by the Texas
- 15 Constitution from serving on the board is eligible, as an
- 16 additional duty of office, to serve on the board. An elected
- 17 officer who is a board member is not entitled to receive
- 18 compensation for serving as a member but is entitled to
- 19 reimbursement for reasonable expenses incurred in performing
- 20 duties as a member.
- 21 SECTION 3. This Act takes effect immediately if it receives
- 22 a vote of two-thirds of all the members elected to each house, as
- 23 provided by Section 39, Article III, Texas Constitution. If this
- 24 Act does not receive the vote necessary for immediate effect, this
- 25 Act takes effect September 1, 2013.
