A BILL TO BE ENTITLED

1 AN ACT

2 relating to the expansion of the boundaries of the Cibolo Creek
3 Municipal Authority.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 4, Chapter 347, Acts of the 62nd
6 Legislature, Regular Session, 1971, is amended to read as follows:

7 Sec. 4. The district shall comprise all of the territory
8 contained within the following described area:

9 BEGINNING: At a point in Southerly right-of-way line of
10 Lookout Road, and being at the Northeasterly cut back of
11 Toepperwein Road and being a Northwesterly corner of the Nejon Inc.
12 tract as recorded in Volume 9633, Page 621 of the Official Public
13 Records of Bexar County, Texas;

14 THENCE: With the Southerly right-of-way line of Lookout Road,
15 an approximate total distance of 3536 feet to a point feet for the
16 most Westerly corner of the Live Oak JV tract of land as recorded in
17 Volume 6308, Page 1362 of the Official Public Records of Bexar
18 County, Texas;

19 THENCE: Departing the Southerly line of Lookout Road and
20 across said Lookout Road with a curve to the right, in a
21 Northeasterly direction, an approximate distance of 846 feet a
22 point for Northwesterly flare corner of Lookout Road and said FM
23 Loop 1604 East bound access Road, and being the Southeast corner of
24 the Texas Dorado Prop LTD tract as described in Volume 8278, Page

1 937, of the Official Public Records of Bexar County, Texas;

2 THENCE: With the Northwesterly line of Lookout Road, in a
3 Northeasterly direction crossing FM Loop 1604, (a variable width
4 Right of Way), approximately 1965 feet to the Southeasterly corner
5 of the PAL Acquisition LP tract of land as recorded in Volume 11771,
6 Page 2291 of the Official Public Records of Bexar County, Texas;

7 THENCE: Departing the Northwesterly line of Lookout Road,
8 with the Easterly line of said PAL Acquisition tract in a
9 Northwesterly direction an approximate distance of 2020 feet to a
10 point in the Southeasterly Right of way line of the Union Pacific
11 Railroad Right-Of-Way;

12 THENCE in a Northeasterly direction with the Southeasterly
13 Right of way line of said Union Pacific Railroad approximately
14 15,138 feet to a point;

15 THENCE: Departing said Southeasterly line of the Union
16 Pacific Railroad Right of way and in a Northwesterly direction and
17 across said Railroad right-of-way and with the Southwest line of
18 the Scheele Revocable Trust tract as described in Document No.
19 9806000899 of the Official Public Records of Comal County, Texas, a
20 total distance of 2855 feet to the Southeasterly line of another
21 Union Pacific Railroad South Right of way line for the Northwest
22 corner of said Scheele Revocable Trust tract;

23 THENCE: In a Southwesterly direction with the Southeast line
24 of said Union Pacific Railroad right-of-way, an approximate
25 distance of 4430 feet to a point in the Union Pacific Railroad
26 Southeasterly Right of way line;

27 THENCE: Across said Union Pacific Railroad right-of-way and

1 with the City of Garden Ridge Ordinance 471 limits line, in a
2 Northwesterly direction, at approximately 1791 feet passing the
3 Northwesterly right-of-way line of FM 2252, and continuing a total
4 distance of approximately 4430 feet to a point in the Northerly line
5 of the remainder of a 110 acre tract of land conveyed to Lloyd
6 Loehman as recorded in Volume 902, Page 402 of the Official Public
7 Records of Comal County, Texas;

8 THENCE: With the Northwesterly line of said Loehman tract,
9 and the Northwesterly line of Country Oak Estates as recorded in
10 Volume 5, Page 372-373 of the Map and Plat Records of Comal County,
11 Texas, in a Northeasterly direction approximately 2543 feet to a
12 point in the Southwesterly line of Bat Cave Road;

13 THENCE: With said Bat Cave Road and in a Southeasterly
14 direction approximately 366 feet to a point;

15 THENCE: Across said Bat Cave Road, and continuing with the
16 Southeasterly line of Garden Ridge Estates Unit One as recorded in
17 Volume 2, Page 48-49 of the Map and Plat Records of Comal County,
18 Texas an approximate distance of 2108 feet to a point;

19 THENCE: Departing said Garden Ridge Unit One, and across
20 Garden Ridge Estate Unit 7 as recorded in Volume 5, Page 154 of the
21 Map and Plat Records of Comal County, Texas, in a Southeasterly
22 direction and crossing said Garden Ridge Estate Unit 7, Garden
23 Ridge Estates Unit Eleven as recorded in Volume 10, Page 245 of the
24 Map and Plat Records of Comal County, Texas, and Garden Ridge
25 Estates Unit Ten as recorded in Volume 8, Page 42 of the Map and Plat
26 Records of Comal County, Texas, and across FM 2252 an approximate
27 distance of 3247 feet to a point in the Southeasterly right-of-way

1 line of FM 2252;

2 THENCE: With the Southeasterly right-of-way line of FM 2252,
3 and in a Northeasterly direction passing FM 3009 at approximately
4 2500 feet, and continuing with said Southeasterly right-of-way line
5 of FM 2252 a total distance of 7850 feet to a point;

6 THENCE: Departing said Southeasterly right-of-way line of FM
7 2252, and in a Northwesterly direction, crossing said FM 2252, and
8 across the James Heitkamp tract of land as recorded in Volume 730,
9 Page 511 of the Official Public Records of Comal County, Texas, an
10 approximate distance of 2732 feet to a point in the Southeasterly
11 line of Hanson Aggregates tract;

12 THENCE: In a Northeasterly direction with said Southeasterly
13 line of Hanson Aggregates, and across HAW Acquisitions Co. LLC as
14 recorded in Document No. 200206006876 of the Official Public
15 Records of Comal County, Texas, and across the Helen Bitterman
16 tract as recorded in Volume 469, Page 684 of the Official Public
17 Records of Comal County, Texas, and into the Givens Family Ltd.
18 Partnership as recorded in Document No. 9806030776 of the Official
19 Public Records of Comal County, Texas, a total distance of 10522
20 feet to a point and a non-tangent curve to the left;

21 THENCE: With said non-tangent curve to the left and in a
22 Northwesterly direction, said curve having an approximate radius of
23 26,500 feet, and crossing said Givens Family Ltd. Partnership, said
24 HAW Acquisitions Co. LLC, and into the Raymond Dierks tract an
25 approximate distance of 5695 feet to a point;

26 THENCE: Across said Dierks tract in an Easterly direction
27 approximately 2250 feet to the Northeasterly line of said Raymond

1 Dierks property, the Westerly line of the Leroy Wilson tract;

2 THENCE: With the Northeasterly line of said Dierks tract, in
3 a Southeasterly direction to the Southeasterly corner of said
4 Dierks tract;

5 THENCE: Departing said Southeasterly corner and in a
6 Northeasterly direction crossing said Hanson Aggregates tract,
7 crossing the Daniel Ritteman tract, and continuing with the
8 Southeasterly line of Turkey Creek Ranches LTD as recorded in
9 Document No. 9706002093 of the Official Public Records of Comal
10 County, Texas, the Northwesterly line of the Dennis Darling tract
11 as recorded in Document No. 200206002063 of the Official Public
12 Records of Comal County, Texas, an approximate distance of 7484
13 feet to the Northeasterly corner of said Dennis Darling tract;

14 THENCE: Departing the Northeasterly corner of Dennis Darling
15 tract, in a Southeasterly direction with the Southwesterly line of
16 the Dorothy Wenzel tract as recorded in Volume 403, Page 283 of the
17 Official Public Records of Comal County, Texas for an approximate
18 distance of 4325 feet to a point;

19 THENCE: Departing the Southwest line of said Dorothy Wenzel
20 tract, and in a Northeasterly direction, crossing said Dorothy
21 Wenzel tract an approximate distance of 1398 feet to a point for the
22 Northerly corner of the Lori & Debra Swete tract as recorded in
23 Document No. 9706019191 of the Official public Records of Comal
24 County, Texas;

25 THENCE: With the Northeasterly line of said Swete tract in a
26 Southeasterly direction, an approximate distance of 2490 feet to
27 the Northwesterly line of the Union Pacific Railroad Right-Of-Way;

1 THENCE: With the Northwesterly line of said Railroad
2 Right-Of-Way, and in a Northeasterly direction, an approximate
3 distance of 6841 feet to a point for the Southwesterly corner of
4 Cemex Const materials Inc. as recorded in Document No. 200205000047
5 of the Official public Records of Comal County, Texas;

6 THENCE: Departing said Southwesterly corner and across said
7 Union Pacific Railroad in a Southerly direction, approximately 114
8 feet to a point in the Southeasterly line of said Union Pacific
9 Railroad, and being the Northerly corner of a tract of land conveyed
10 to Holnam Inc in Volume 730, Page 900 of the Official Public Records
11 of Comal County, Texas;

12 THENCE: In a Southeasterly direction, with the Northeasterly
13 line of said Holnam tract, 1830 feet to the an Easterly corner of
14 said Holnam tract of land, and being in the Northerly line of the
15 Carol Staats tract of land as recorded in Volume 866, Page 128 of
16 the Official Public Records of Comal County, Texas;

17 THENCE: Departing said Easterly corner of said Holnam Inc.
18 tract, in a Westerly direction, approximately 343 feet to the
19 Northwest corner of said Carol Staats tract of land;

20 THENCE: Continuing with the Southwesterly line of Carol
21 Staats tract of land, in a Southeasterly direction passing the
22 Southwest corner of Carol Staats at approximately 1208 feet, and
23 continuing across a Union Pacific Railroad Right-of-Way, for a
24 total distance of approximately 1322 feet to a point for the
25 Northeasterly corner of the Kathleen Hoffman tract as recorded in
26 Volume 866, Page 128 of the Official Public Records of Comal County,
27 Texas;

1 THENCE: With the Easterly line of said Kathleen Hoffman tract
2 of land, in a Southeasterly direction, passing the Southeasterly
3 corner of said Hoffman tract at approximately 170 feet, and
4 continuing across Farm to Market Road 482 for a total distance of
5 227 feet to a point;

6 THENCE: In a Southwesterly direction, and with the
7 Southeasterly Right of Way line of Farm to Market Road 482,
8 approximately 594 feet to a point in the Northerly line of a tract
9 of land conveyed to Jeri Hoffman and the Northeasterly corner of a
10 tract conveyed to IH 35 Investments as recorded in Document No.
11 200806006653 of the Official Public Records of Comal County, Texas;

12 THENCE: With the Northeasterly line of said IH 35
13 Investments, in a Southeasterly direction an approximate distance
14 of 3145 feet to a point in the Northwesterly line of the Rancho
15 Wayno LLC tract as recorded in in Volume Document No. 201006000630
16 of the Official Public Records of Comal County, Texas;

17 THENCE: With the Northwesterly line of Rancho Wayno LLC, in a
18 Northeasterly direction approximately 23 feet to the Northeast
19 corner of said Rancho Wayno LLC tract;

20 THENCE: Departing said Northeast corner and in a
21 Southeasterly direction approximately 262 feet to a point in the
22 Northwesterly right-of-way line of Interstate Highway 35 for the
23 Southeasterly corner of said Rancho Wayno tract;

24 THENCE: With the Northwest right-of-way line of IH 35, in a
25 Northeasterly direction approximately 513 feet to a point;

26 THENCE: Departing the Northwest right-of-way line of IH 35,
27 in a Southeasterly direction, and across said IH 35, a distance of

1 approximately 300 feet to a point in the Southerly line of said IH
2 35, and being in the Northwest line of the Khamapirad Family Ltd
3 Partnership as recorded in Document No.20120603282 of the Official
4 Public Records of Comal County, Texas;

5 THENCE: With said Khamapirad Family Ltd Partnership
6 Northwest line and Southeasterly line of IH 35 in a Northeasterly
7 direction an approximate distance of 1066 feet to the Northerly
8 corner of said Khamapirad Family Ltd Partnership tract;

9 THENCE: Departing IH 35, and with the Easterly line of the
10 Khamapirad Family Ltd Partnership, and continuing with the Easterly
11 line of the Dennis Engle tract as recorded in Volume 941, page 328
12 of the Official Public Records of Comal County, Texas in a
13 Southeasterly direction approximately 2626 feet to an interior
14 corner in said Dennis Engle tract;

15 THENCE: Departing said interior corner and in a Northeasterly
16 direction a distance of approximately 1071 feet to the Westerly
17 line of Engle Road for a corner;

18 THENCE: With said Westerly line of Engle Road and in a
19 Southeasterly direction, at approximately 980 feet passing the
20 approximate Comal County and Guadalupe County lines and continuing
21 a total approximate distance of 6279 feet to a point in the
22 Southeasterly line of Engel Road to a point in a non-tangent curve
23 in the Northwesterly line of the Goswin Klaerner Revocable Trust
24 tract, as described in Volume 2123, Page 425 of the Official Public
25 Records of Guadalupe County Texas;

26 THENCE: With the Southeasterly line of Engel Road, a curve to
27 the Southwest approximately 80 feet to a point;

1 THENCE: Departing Engel Road and in a Southeasterly
2 direction, crossing the Goswin Klaerner revocable Trust tract, and
3 passing the Northwesterly line of the Reno Engel tract at
4 approximately 1500 feet, and continuing a total approximate
5 distance of 1872 feet to the beginning of a non-tangent curve to the
6 left for a corner;

7 THENCE: In a Southerly direction, with said curve to the
8 left, having a radius of 3000 feet and an arc distance of 3558 feet,
9 across said Reno Engel tract and the Clifton Engel tract as
10 described in Volume 782, Page 488 of the Official Public Records of
11 Guadalupe County, and passing the Southwesterly corner of said
12 Engel tract and into the Weston Ranch Foundation tract as described
13 in Volume 2338, Page 451 of the Official Public Records of Guadalupe
14 County, Texas, to a point for a non-tangent curve to the left;

15 THENCE: Continuing through said Weston Ranch Foundation
16 Tract and in a Southwesterly direction with said curve to the left
17 with a radius of 3000 feet, an approximate distance 985 feet to a
18 point beginning of a non-tangent curve to the left;

19 THENCE: Continuing in a Southwesterly direction with another
20 non-tangent curve to the left having a radius of 3000 feet, an arc
21 length of 1550 feet to a point for a non-tangent curve to the left

22 THENCE: Continuing through said Weston Ranch Foundation
23 Tract and in a Southwesterly direction with said non-tangent curve
24 to the left with a radius of 3000 feet, an approximate distance 985
25 feet to a point for the beginning of another non-tangent curve to
26 the left;

27 THENCE: In a Southwesterly direction and with a curve to the

1 left having a radius of 3000 feet, through said Weston Ranch tract,
2 passing the Westerly line of Koehler Road at approximately 540
3 feet, and continuing a total distance of 1836 feet into the Weston
4 Ranch tract as described in Volume 2338 Page 452 of the Official
5 Public Records of Guadalupe County, Texas, to the beginning of a
6 curve to the left and a corner of this herein described political
7 boundary;

8 THENCE: In a Southwesterly direction, continuing through
9 said Weston Ranch tract and with said curve to the left having a
10 radius of 3200 feet and arc length of 1187 feet, to a point for
11 corner;

12 THENCE in a Northwesterly direction continuing across said
13 Weston Ranch Foundation tract an approximate distance of 644 feet
14 to a point for corner;

15 THENCE: In a Southwesterly direction, crossing the
16 Northeasterly line of the Teofilo Ortiz tract as described in
17 Volume 972, Page 280 of the Official Public Records of Guadalupe, at
18 approximately 400 feet, continuing an approximate distance of 813
19 feet to a point in the Southerly line of said Teofilo Ortiz tract
20 for a corner;

21 THENCE: In a Southwesterly direction, at 622 feet departing
22 the Teofilo Ortiz Southwesterly corner and continuing across the
23 Hunter Creek Enterprises tract as described in Volume 2790, Page
24 362 of the Official Public Records of Guadalupe County, Texas for a
25 total distance of 2160 feet to a Westerly corner of said Hunter
26 Creek Enterprises tract for a corner;

27 THENCE: With the Southwesterly line of said Hunters Creek

1 Enterprises tract, in a Southeasterly direction approximately 341
2 feet to a point for corner;

3 THENCE: Departing said Southwesterly line and into Hunters
4 Creek Enterprises tract, in an Easterly direction 3221 feet to a
5 point for corner, and Southeasterly 224 feet to a corner, and
6 Southwesterly 242 feet to a point in the Southwesterly line of said
7 Hunters Creek Enterprise tract for a corner,

8 THENCE: In a Southeasterly direction with the Southwest line
9 of Hunters Creek Enterprises, approximately 486 feet to a
10 Southwesterly corner of Hunters Creek Enterprises tract, and being
11 in the northwesterly line of the Frederich Goerke tract as recorded
12 in Volume 1517, Page 108 of the Official Public Records of Guadalupe
13 County, Texas;

14 THENCE: With the Northwesterly line of the Goerke tract and
15 in a Southwesterly direction approximately 1391 feet to a point for
16 the Westerly corner of said Goerke tract;

17 THENCE: Continuing with the Frederich Goerke tract, in a
18 Southeasterly direction, passing a Southerly corner of Goerke, the
19 Westerly corner of David Elder tract as recorded in Volume 1859,
20 Page 880 of the Official Public Records of Guadalupe County, Texas,
21 at approximately 1493 feet, and continuing with said David Elder
22 tract and passing said Southerly corner at approximately 1748, and
23 across Weil road for a total distance of 1798 feet to a point;

24 THENCE: With the Southeasterly line of Weil road, in a
25 Northeasterly direction 150 feet to the Northwest corner of the
26 Osborn Trust tract as described in Volume 1693, Page 2434 of the
27 Official Public Records of Guadalupe County, Texas, for a corner;

1 THENCE: Departing Weil Road and in a Southeasterly direction
2 with the Southwest line of the Osborn Trust tract, and passing the
3 Southwesterly corner of said Osborn Trust tract at 662 feet and
4 continuing with the a Westerly line of the Robert Walker tract as
5 described in Volume 1517, Page 255 of the Official Public Records of
6 Guadalupe County, Texas, an approximate distance of 833 feet to a
7 point for a corner;

8 THENCE: Continuing with said Robert Walker tract in a
9 Southwesterly direction approximately 280 feet to a point for
10 corner, and in a Southeasterly direction with said Robert Walker
11 Southwesterly line, an approximate distance of 1210 feet to the
12 Southwest corner of said Robert Walker tract for a corner and being
13 in the Northwesterly line of Short Weyel Road;

14 THENCE: With the Northwesterly line of Short Weyel Road, and
15 departing Short Weyel Road at 375 feet, and continuing in a
16 Northeasterly direction with the Southeast line of the Robert
17 Walker tract approximately 1441 feet to a point in the
18 Northwesterly line of the Fey D. Fay tract as described in Volume
19 2651, Page 335 of the Official Public Records of Guadalupe County,
20 Texas for a corner;

21 THENCE: Departing said Robert Walker tract, and across said
22 Fey D. Fay tract in a Southeasterly direction, at approximately
23 1025 feet passing the Southeasterly line of said Fey D. Fay tract,
24 the Northwesterly line of David Lee tract as recorded in Volume
25 3051, Page 355 of the Official Public Records of Guadalupe County
26 Texas, and continuing across said David lee tract for a total
27 distance of 2163 feet to an interior corner of the Monroe

1 Freisenhahn 125 acre tract for a corner;

2 THENCE: With the Northwest line of the Monroe Freisenhahn 125
3 acre tract and in a Northeasterly direction approximately 825 feet
4 to the Westerly corner of Santa Clara Bend Phase 3 Subdivision as
5 recorded in Volume 6, Page 142 of the Map and Plat Records of
6 Guadalupe County, Texas for a corner;

7 THENCE: In a Southeasterly direction with the Southwesterly
8 line of Santa Clara Bend Phase 3 Subdivision an approximate
9 distance of 1874 feet to the Westerly corner of the Elsie Bischoff
10 tract as recorded in Probate, Volume 8307, of the Official Public
11 Records of Guadalupe County, Texas;

12 THENCE: With the Southwesterly line of the Elsie Bischoff
13 tract approximately 267 feet to a point for corner;

14 THENCE: Departing said Elsie Bischoff tract and in a
15 Southwesterly direction, across said Monroe Freisenhahn 125 acre
16 tract, at approximately 2262 passing into the Monroe Freisenhahn
17 21.663 acre tract described in Volume 1601, Page 481 of the Official
18 Public Records of Guadalupe County, Texas, and at approximately
19 2750 feet passing Easterly corner of Sassman Road Estates
20 Subdivision as recorded in Volume 5, Page 58 of the Map and Plat
21 Records of Guadalupe County, Texas for a corner and continuing with
22 the Southeasterly line of said Sassman Road Estates Subdivision for
23 an approximate total distance of 3341 feet to the Southwesterly
24 corner of Lot 18 for a corner;

25 THENCE: In a Southwesterly direction, departing the
26 Southeasterly line of Sassman Road Estates Subdivision and with a
27 non-tangent curve to the left having a radius of approximately 2125

1 feet and passing through the Thomas Walker tract as described in
2 Volume 1632, Page 641, the Carter Family Trust tract as described in
3 Volume 1865, Page 486, of the Official Public Records of Guadalupe
4 County, Texas, the Carter Family Trust tract as described in Volume
5 1514, Page 122 of the Official Public Records of Guadalupe County,
6 Texas, the Alonzo Andrews tract as described in Volume 1338, Page
7 330, and the Felix Aguirre tract as described in Volume 1226, Page
8 496 of the Official Public Records of Guadalupe County, Texas to a
9 point in the Easterly line of Sassman Road;

10 THENCE: With the Northeasterly line of Sassman Road, in a
11 Southeasterly direction, approximately 1204 feet to a point in the
12 Southeasterly line of Country lane;

13 THENCE: With the Southeasterly line of County lane and in a
14 Southwesterly direction approximately 127 feet to a point for the
15 Northwesterly corner of the Michelle Ford tract as recorded in
16 Volume 2399, Page 141 of the Official Public Records of Guadalupe
17 County, Texas;

18 THENCE: With the Southwesterly line of said Michelle Ford
19 tract and in a Southeasterly direction, at 2227 feet passing the
20 Northwesterly line of Union Pacific Railroad, and continuing a
21 total distance of 2450 feet to the Southern right-of-way line of FM
22 78;

23 THENCE: With the Southern right-of-way of FM 748 and in an
24 Easterly direction an approximate distance of 5575 feet to a point
25 in the Northerly line of the Fred Wagner tract as recorded in Volume
26 2947, Page 629 of the Official Public Records of Guadalupe County,
27 Texas;

1 THENCE: Departing FM 78 and across said Fred Wagner tract in a
2 Southerly direction, approximately 576 feet to Town Creek;

3 THENCE: With the meanders of Town Creek and crossing the
4 Westerly line of Helen Brietzke tract of land as recorded in Volume
5 3031, Page 915 of the Official Public Records of Guadalupe County;

6 THENCE in a Southerly direction, continuing through said
7 Helen Brietzke tract and with the meanders of Town Creek
8 approximately 4300 feet to a point;

9 THENCE: Departing Town Creek and in a Westerly direction,
10 passing at 580 feet, the Westerly line of said Brietzke the Easterly
11 line of Stanley Cielencjki tract of land as recorded in Volume 1022,
12 Page 369 of the Official Public Records of Guadalupe County, Texas,
13 continuing across said Cielencjki tract 1538 feet, passing the
14 Westerly line of Cielencjki tract, the Easterly line of Ray Joe
15 Pfannstiel tract of land as recorded in Volume 1300, Page 325 of the
16 Official Public Records of Guadalupe County, Texas, and continuing
17 across said Ray Joe Pfannstiel tract of land 2480 feet to a point, a
18 total distance of 4598 feet to a point in the Southerly line of said
19 Pfannstiel Road;

20 THENCE: With said Pfannstiel Road and in a Northeasterly
21 direction to a point in Town Creek;

22 THENCE: With the meanders of Town Creek and in a Westerly
23 direction approximately 730 feet to a point;

24 THENCE: Departing Town Creek and in a Southeasterly direction
25 to the Southerly line of Pfannstiel Lane, a northerly line of said
26 Gladys Pfannstiel tract for a point;

27 THENCE: Departing Pfannstiel Lane and in a Southeasterly

1 direction across the Gladys Pfannstiel tract approximately 975 feet
2 to the beginning of a non-tangent curve to the right;

3 THENCE: In a Southeasterly direction with said non-tangent
4 curve to the right, having an approximate radius of 23,500 feet
5 across the Gladys Pfannstiel tract, across the Barbara Schmoekel

16 introduce this Act, setting forth the general substance of this
17 Act, has been published as provided by law, and the notice and a
18 copy of this Act have been furnished to all persons, agencies,
19 officials, or entities to which they are required to be furnished
20 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
21 Government Code.

22 (b) The governor, one of the required recipients, has
23 submitted the notice and Act to the Texas Commission on
24 Environmental Quality.

25 (c) The Texas Commission on Environmental Quality has filed
26 its recommendations relating to this Act with the governor, the
27 lieutenant governor, and the speaker of the house of

1 representatives within the required time.

2 (d) All requirements of the constitution and laws of this
3 state and the rules and procedures of the legislature with respect
4 to the notice, introduction, and passage of this Act are fulfilled
5 and accomplished.

6 SECTION 3. This Act takes effect immediately if it receives
7 a vote of two-thirds of all the members elected to each house, as
8 provided by Section 39, Article III, Texas Constitution. If this
9 Act does not receive the vote necessary for immediate effect, this
10 Act takes effect September 1, 2013.
