- 23 (5) be substantially undeveloped and be located in: 24 (A) a municipality with a population of less than 25 20,000; and 26 (B) a county with a population of more than 660,000 and less than 690,000 that borders a county with a 27

- 1 population of two million or more.
- 2 SECTION 2. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2013.
