15	(1) post as early as practicable in advance of the
16	meeting on the Internet website of the district any written agenda
17	and related supplemental written materials provided by the district
18	to the board members for the members' use during the meeting;
19	(2) broadcast the meeting, other than any portions of
20	the meeting closed to the public as authorized by law, over the
21	Internet in the manner prescribed by Section 551.128; and
22	(3) record the broadcast and make that recording
23	publicly available in an online archive located on the district's

(c) Subsection (b)(1) does not apply to written materials 1 that the general counsel or other appropriate attorney for the 2 district certifies are confidential or may be withheld from public 3 disclosure under Chapter 552. 4 5 (d) The governing board of a junior college district is not 6 required to comply with the requirements of this section if that compliance is not possible because of an act of God, force majeure, 7 or a similar cause not reasonably within the governing board's 8 9 control. SECTION 2. The change in law made by this Act applies only 10

10 SECTION 2. The change in law made by this Act applies only 11 to a meeting of the governing board of a junior college district for 12 which notice is given under Chapter 551, Government Code, on or 13 after January 1, 2014.

14 SECTION 3. This Act takes effect immediately if it receives 15 a vote of two-thirds of all the members elected to each house, as 16 provided by Section 39, Article III, Texas Constitution. If this 17 Act does not receive the vote necessary for immediate effect, this 18 Act takes effect September 1, 2013.
