A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the transfer of certain state property in Walker County
- 3 from the Texas Board of Criminal Justice to the board of regents of
- 4 the Texas State University System.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. (a) Not later than January 1, 2014, the Texas
- 7 Board of Criminal Justice shall donate and transfer the real
- 8 property described by Subsection (e) of this section to the board of
- 9 regents of the Texas State University System for use by Sam Houston
- 10 State University.
- 11 (b) The Texas Board of Criminal Justice shall convey the
- 12 property by a deed without warranty regarding covenants of title.
- 13 (c) The deed must include a provision that:
- 14 (1) requires Sam Houston State University to use the
- 15 property primarily for a purpose that benefits the public interest
- 16 of the state; and
- 17 (2) indicates that ownership of the property will
- 18 automatically revert to the Texas Board of Criminal Justice if Sam
- 19 Houston State University fails to use the property primarily for a
- 20 purpose that benefits the public interest of the state.
- 21 (d) The Texas Board of Criminal Justice shall retain custody
- 22 of the deed after the deed is filed in the real property records of
- 23 Walker County.
- 24 (e) The real property referred to in this section is

- 1 described as follows:
- Being 78.823 acres of land, more or less, situated in the City
- 3 of Huntsville, P. GRAY SURVEY, Abstract No. 24, Walker County,
- 4 Texas and being out of and a part of a called 515 acre tract as
- 5 described in a Deed from Ed H. Cunningham, et al to the State of
- 6 Texas, dated July 10, 1883 and recorded in Volume Y, Page 181, Deed
- 7 Records, said 78.823 acre tract being more definitely described as
- 8 follows:
- 9 BEGINNING at the northeast corner of a called 5.00 acre
- 10 tract, out of said 515 acre tract, as described in a Deed from the
- 11 Texas Board of Criminal Justice, on behalf of the Texas Department
- 12 of Criminal Justice, to the County of Walker (Veteran's Complex),

- THENCE SO2°32'37"E, with the east line of said 515 acre tract
- 8 and the called west line of said Heaton tract, at 660.0 pass the
- 9 apparent southwest corner of said Heaton tract, continuing for a

- 2 SECTION 2. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2013.
