A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of a commission to review certain penal 3 laws of this state. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. COMMISSION TO STUDY CERTAIN PENAL LAWS. (a) Α commission is created to study and review all penal laws of this 6 state other than criminal offenses: 7 (1) under the Penal Code; 8 9 (2) under Chapter 481, Health and Safety Code; or related to the operation of a motor vehicle. 10 (3) 11 (b) The commission shall: (1) evaluate all laws described by Subsection (a) of 12 this section; and 13 14 (2) make recommendations to the legislature regarding the repeal of laws that are identified as being unnecessary, 15 16 unclear, duplicative, overly broad, or otherwise insufficient to serve the intended purpose of the law. 17 The commission is composed of nine members appointed as 18 (c) follows: 19 20 (1)two members appointed by the governor; 21 (2) two members appointed by the lieutenant governor; 22 two members appointed by the speaker of the house (3) 23 of representatives; two members appointed by the chief justice of the 24 (4)

1 Supreme Court of Texas; and

2 (5) one member appointed by the presiding judge of the3 Texas Court of Criminal Appeals.

4 (d) The officials making appointments to the commission 5 under Subsection (c) of this section shall ensure that the 6 membership of the commission includes representatives of all areas 7 of the criminal justice system, including prosecutors, defense 8 attorneys, judges, legal scholars, and relevant business 9 interests.

10 (e) The governor shall designate one member of the11 commission to serve as the presiding officer of the commission.

12 (f) A member of the commission is not entitled to 13 compensation or reimbursement of expenses.

14 (g) The commission shall meet at the call of the presiding 15 officer.

Not later than November 1, 2014, the commission shall 16 (h) 17 report the commission's findings and recommendations to the governor, the lieutenant governor, the speaker of the house of 18 representatives, the Supreme Court of Texas, the Texas Court of 19 Criminal Appeals, and the standing committees of the house of 20 representatives and the senate with primary jurisdiction over 21 22 criminal justice. The commission shall include in its 23 recommendations any specific statutes that the commission 24 recommends revising or repealing.

25 SECTION 2. APPOINTMENT OF MEMBERS. Not later than the 60th 26 day after the effective date of this Act, the governor, the 27 lieutenant governor, the speaker of the house of representatives,

1 the chief justice of the Supreme Court of Texas, and the presiding 2 judge of the Texas Court of Criminal Appeals shall appoint the 3 members of the commission created under this Act.

4 SECTION 3. ABOLITION OF COMMISSION. The commission is 5 abolished and this Act expires December 31, 2014.

6 SECTION 4. EFFECTIVE DATE. This Act takes effect 7 immediately if it receives a vote of two-thirds of all the members 8 elected to each house, as provided by Section 39, Article III, Texas 9 Constitution. If this Act does not receive the vote necessary for 10 immediate effect, this Act takes effect September 1, 2013.
