| 11 | officer may provide notice to the owner at the time the owner is |

- 1 after the date the owner signed the notice, the peace officer shall deliver the property for disposition to a person designated by the 2 municipality or to the purchasing agent or sheriff of the county in 3 which the property was seized, as applicable. 4 The person designated by the municipality, the purchasing agent, or the 5 sheriff may sell or donate the property without mailing or 6 7 publishing an additional notice as required by Subsection (b), (c), or (d). The sale proceeds, after deducting the reasonable expense 8 of keeping and disposing of the property, must be deposited in the 9 treasury of the municipality or county disposing of the property. 10
- SECTION 2. Article 18.17, Code of Criminal Procedure, as amended by this Act, applies to personal property seized or taken into custody on or after the effective date of this Act. Personal property seized or taken into custody before the effective date of this Act is governed by the law in effect on the date the property is seized or taken into custody, and the former law is continued in effect for that purpose.
- SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.
