(a) In this 12 section: (1) "Autonomous motor vehicle" means a motor vehicle 13 14 that uses autonomous technology to operate itself without the active control or continuous monitoring of a person. 15 (2) "Autonomous technology" means technology 16 installed on a motor vehicle enabling the vehicle to operate 17 without the active control or continuous monitoring of a person. 18 The term does not include, except to the extent that such a system 19 may be a component of autonomous technology, individual safety 20 systems or driver assistance systems that enhance safety or provide 21 driver assistance, but are not individually capable of operating a 22 23 motor vehicle without the active control or continuous monitoring of a person, such as systems designed to provide: 24

7	SECTION 3. This Act takes effect immediately if it receives
