12 The labeling requirements provided by Subsection (a)(9) do not

13 apply to a dealer who sells taxable diesel fuel blended with

14 materials described by Subsection (a)(9) on which tax has been paid

15 as provided by this subsection. Materials described by Subsection

16 (a)(9) on which tax has been paid as provided by this subsection are

17 not exempt from tax under Subsection (a)(9) on a subsequent sale,

18 and a license holder or other purchaser is not entitled to a refund

19 or credit under Subsection (a)(9) for a purchase of taxable diesel

20 <u>fuel blended with those materials.</u>

21 SECTION 2. The change in law made by this Act does not

22 affect tax liability accruing before the effective date of this

23 Act. That liability continues in effect as if this Act had not been
