H.B. No. 3432

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the salary reclassification of certain positions with
3 the Department of Public Safety of the State of Texas and the Office
4 of the Attorney General.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. (a) The classification officer in the office of
7 the state auditor shall reclassify the following positions with the
8 Department of Public Safety of the State of Texas under the Texas
9 Position Classification Plan, 1961:

10 (1) the positions of Sergeant and Pilot Investigator I
11 shall be reclassified as salary group C5 positions;

12 (2) the positions of Lieutenant and Pilot Investigator
13 II shall be reclassified as salary group C6 positions; and

14 (3) the positions of Captain, Pilot Investigator III,
15 and Inspector II shall be reclassified as salary group C8
16 positions.

17 (b) The classification officer in the office of the state
18 auditor shall replace the position of Trooper in the Department of
19 Public Safety of the State of Texas with the following new positions
20 under the Texas Position Classification Plan, 1961:

21 (1) the position of Trooper I classified as a salary
22 group C3 position; and

23 (2) the positions of Trooper II, III, IV, V, and VI
24 classified as salary group C4 positions.

1 (c) The classification officer in the office of the state
2 auditor shall replace the position of Corporal in the Department of
3 Public Safety of the State of Texas with the following new positions
4 under the Texas Position Classification Plan, 1961:

5 (1) the position of Corporal I classified as a salary
6 group C3 position; and

7 (2) the positions of Corporal II, III, IV, V, and VI
8 classified as salary group C4 positions.

9 SECTION 2. The classification officer in the office of the
10 state auditor shall reclassify the following positions with the
11 Office of the Attorney General under the Texas Position
12 Classification Plan, 1961:

13 (1) the position of Sergeant shall be reclassified as
14 a salary group C4 position;

15 (2) the position of Lieutenant shall be reclassified
16 as a salary group C5 position;

17 (3) the position of Captain shall be reclassified as a
18 salary group C6 position; and

19 (4) the position of Major shall be reclassified as a
20 salary group C8 position.

21 SECTION 3. The changes made by the classification officer
22 as required by Sections 1 and 2 of this Act apply beginning in the
23 state fiscal biennium beginning September 1, 2013.

24 SECTION 4. This Act takes effect immediately if it receives
25 a vote of two-thirds of all the members elected to each house, as
26 provided by Section 39, Article III, Texas Constitution. If this
27 Act does not receive the vote necessary for immediate effect, this
