A BILL TO BE ENTITLED AN ACT

1-19 relating to requirements for a driver education course and the eligibility of persons under 18 years of age to operate a motor 1-20 vehicle at certain times. 1-21

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 1-23 SECTION 1. Section 1001.101, Education Code, as amended by Chapters 1253 (H.B. 339) and 1413 (S.B. 1317), Acts of the 81st 1-24 Legislature, Regular Session, 2009, is reenacted and amended to 1-25 1-26 read as follows:

Sec. 1001.101. ADULT AND MINOR DRIVER EDUCATION COURSE CURRICULUM AND TEXTBOOKS. (a) The commissioner by rule shall 1-27 1-28 1-29 establish or approve the curriculum and designate the textbooks to 1-30 be used in a driver education course for minors and adults, 1-31 including a driver education course conducted by a school district, 1-32 driver education school, or parent or other individual under 1-33 Section 521.205, Transportation Code.

A driver education course must require the student to 1-34 (b) 1-35 complete:

(1) 7 hours of behind-the-wheel instruction in the presence of a person who holds a driver education instructor license or who meets the requirements imposed under Section 1-36 1-37 1-38 521.205, Transportation Code; 1-39

(2) 7 hours of observation instruction in the presence 1-40 1-41 of a person who holds a driver education instructor license or who 1-42 meets the requirements imposed under Section 521.205, 1-43 Transportation Code; and

(3) $\underline{30}$ [$\underline{20}$] hours of behind-the-wheel instruction, including at least 10 hours of instruction that takes place at 1 - 441-45 night, in the presence of an adult who meets the requirements of Section 521.222(d)(2), Transportation Code. 1-46 1-47

SECTION 2. Section 545.424(a-1), Transportation Code, is 1-48 1-49 amended to read as follows:

1-50 (a-1) A person under 18 years of age may not operate a motor vehicle [during the 12-month period following issuance of original Class A, B, or C driver's license to the person]: 1-51 an 1-52

1-53 (1) after midnight and before 5 a.m. unless the 1-54 operation of the vehicle is necessary for the operator to attend or 1-55 participate in employment or a school-related activity or because of a medical emergency; or 1-56

1-57 (2) with more than one passenger in the vehicle under 1-58 21 years of age who is not a family member.

1-59 SECTION 3. The change in law made by Section 1001.101(b), Education Code, as amended by this Act, applies only to a driver education course that begins on or after the effective date of this 1-60 1-61

H.B. No. 3483 Act. A course that begins before the effective date of this Act is governed by the law in effect on the date the course began, and that law is continued in effect for that purpose. SECTION 4. This Act takes effect September 1, 2013. 2-1 2-2 2-3
