11	(1) "Governing body of a municipality" includes the
12	presiding officer of the municipality.
13	(2) "Municipal term limit" means a provision in a
14	municipal charter or ordinance that imposes a limit on the number of
15	terms or otherwise restricts the length of service a member of the
16	governing body of a municipality may serve on the governing body.
17	(c) The governing body of the municipality shall decide
18	whether an election held under this section will authorize term
19	limits for members of the governing body of the municipality
20	consisting of a maximum of:
21	(1) three four-year terms; or
22	(2) six two-year terms.
23	(d) The presiding officer of a municipality shall order an
24	election in the municipality on the first uniform election date in

No. 3794 November that occurs in an even-numbered year after this section 1 2 becomes applicable to the municipality on the question of imposing term limits on the members of the governing body of the 3 4 municipality. 5 (e) The ballot at the election must be printed to permit voting for or against the proposition: "Authorizing term limits 6 7 consisting of (insert number of terms and length of terms) on a 8 person's service on the governing body of the City of (insert name of municipality)." 9 10 (f) If a majority of the votes received at the election favor the proposition, the number and length of terms a person may 11 12 serve on the governing body is limited as provided in the proposition. The municipality shall adjust the length of the terms 13 14 of the members of the governing body as necessary to comply with the 15 proposition. (g) If less than a majority of the votes received at the 16 17 election favor the proposition, municipal term limits and the length of the terms of the members of the governing body that 18 19 existed before the election are not affected. (h) In applying a term limit authorized by this section: 20 21 (1) a term to which a member of the governing body was elected or appointed before the election held under Subsection (d) 22 is counted only if the member served one-half or more of the term; 23 24 and 25 (2) a partial term to which a member of the governing 26 body is elected or appointed on or after the date of the election held under Subsection (d) is counted only if the member serves 27

2	(i) This section expires January 1, 2015.
3	SECTION 2. This Act takes effect September 1, 2013.
