BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Chapter 268, Acts of the 55th Legislature, Regular Session, 1957, is amended by adding Section 1A to read as follows:

(a) The district shall be governed by a board of Sec. 1A. five elected directors.

(b) Directors serve staggered four-year terms and until

their successors have qualified.

(c) On the uniform election date in May of each odd-numbered year, the appropriate number of directors shall be elected.

SECTION 2. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.

- The governor, one of the required recipients, has the notice and Act to the Texas Commission on (b) submitted Environmental Quality.
- (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the of lieutenant governor, and the speaker the representatives within the required time.
- (d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

1-50 This Act takes effect immediately if it receives 1-51 SECTION 3. a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.
