H.B. No. 3910

A BILL TO BE ENTITLED

AN ACT

relating to the boundaries of the East Montgomery County Municipal Utility Districts Nos. 6 and 7.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 2, Chapter 775, Acts of the 79th Legislature, Regular Session, 2005, is amended to read as follows:

Sec. 2. (a) The ~~[Each district initially includes, respectively, the territory contained in the following areas as indicated.]~~

~~(1)~~ East Montgomery County Municipal Utility District No. 5 initially includes the territory in the following described areas:

PARCEL ONE

19       SECTION 2. The East Montgomery County Municipal Utility  
20 Districts Nos. 6 and 7 retain all rights, powers, privileges,  
21 authority, duties, and functions that they had before the effective  
22 date of this Act. Notwithstanding any other law, the East  
23 Montgomery County Municipal Utility Districts Nos. 6 and 7 may  
24 continue to rely on any bond election held before the effective date  
25 of this Act.

26       SECTION 3. (a) The legislature validates and confirms all  
27 governmental acts and proceedings, including an election, of the

1 East Montgomery County Municipal Utility Districts Nos. 6 and 7  
2 that were taken before the effective date of this Act.

14 territory of the East Montgomery County Municipal Utility District  
15 No. 5.

16 SECTION 5. (a) The legal notice of the intention to  
17 introduce this Act, setting forth the general substance of this  
18 Act, has been published as provided by law, and the notice and a  
19 copy of this Act have been furnished to all persons, agencies,  
20 officials, or entities to which they are required to be furnished  
21 under Section 59, Article XVI, Texas Constitution, and Chapter 313,  
22 Government Code.

23 (b) The governor, one of the required recipients, has  
24 submitted the notice and Act to the Texas Commission on  
25 Environmental Quality.

26 (c) The Texas Commission on Environmental Quality has filed  
27 its recommendations relating to this Act with the governor, the

1 lieutenant governor, and the speaker of the house of  
2 representatives within the required time.

3 (d) All requirements of the constitution and laws of this  
4 state and the rules and procedures of the legislature with respect  
5 to the notice, introduction, and passage of this Act are fulfilled  
6 and accomplished.

7 SECTION 6. This Act takes effect September 1, 2013.
