- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 24.113, Government Code, is amended to
- 8 read as follows:
- 9 Sec. 24.113. 12TH JUDICIAL DISTRICT (GRIMES, [LEON,]
- 10 MADISON, AND WALKER COUNTIES).  $[\frac{a}{a}]$  The 12th Judicial District is
- 11 composed of Grimes, [Leon,] Madison, and Walker counties.
- 12 [(b) The terms of the 12th District Court in each county of
- 13 the district begin on the first Mondays in January and July.
- 14 SECTION 2. Section 24.514, Government Code, is amended to
- 15 read as follows:
- 16 Sec. 24.514. 369TH JUDICIAL DISTRICT (ANDERSON, [AND]
- 17 CHEROKEE, AND LEON COUNTIES). The 369th Judicial District is
- 18 composed of Anderson, [and] Cherokee, and Leon counties.
- 19 SECTION 3. Section 43.106, Government Code, is redesignated
- 20 as Section 43.1815, Government Code, and amended to read as
- 21 follows:
- 22 Sec. 43.1815 [43.106]. 369TH [12TH] JUDICIAL DISTRICT. (a)
- 23 The voters of Leon County elect a district attorney for the 369th
- 24 [12th] Judicial District who represents the state in that district

- 1 court only in Leon County.
- 2 (b) The district attorney of the 369th [12th] Judicial
- 3 District also represents the state in all criminal and civil
- 4 actions in which the state is interested that arise in the 87th
- 5 Judicial District in Leon County.
- 6 (c) The district attorney may, with the consent of the
- 7 Commissioners Court of Leon County, appoint a deputy district
- 8 attorney.
- 9 (d) The Commissioners Court of Leon County shall pay the
- 10 salary and traveling expenses of the deputy district attorney from
- 11 the officers' salary fund. The salary shall be paid in equal monthly
- 12 installments and expense claims shall be paid at the end of each
- 13 month. The salary is subject to participation fully in the Texas
- 14 County and District Retirement System.
- 15 SECTION 4. Section 46.002, Government Code, is amended to
- 16 read as follows:
- 17 Sec. 46.002. PROSECUTORS SUBJECT TO CHAPTER. This chapter
- 18 applies to the state prosecuting attorney, all county prosecutors,
- 19 and the following state prosecutors:

- 17 SECTION 5. Section 152.1511(a), Human Resources Code, as
- 18 amended by Chapters 531 (H.B. 956), 1152 (H.B. 3045), and 1352 (S.B.
- 19 1189), Acts of the 79th Legislature, Regular Session, 2005, is
- 20 reenacted to read as follows:
- 21 (a) The juvenile board of Leon County is composed of the
- 22 county judge and the district judges in Leon County.
- 23 SECTION 6. (a) The local administrative district judge
- 24 shall transfer all cases from Leon County that are pending in the
- 25 12th District Court on September 1, 2013, to the 369th District
- 26 Court.
- (b) When a case is transferred as provided by Subsection (a)

- 1 of this section, all processes, writs, bonds, recognizances, or
- 2 other obligations issued from the 12th District Court are
- 3 returnable to the 369th District Court as if originally issued by
- 4 that court. The obligees on all bonds and recognizances taken in
- 5 and for the 12th District Court and all witnesses summoned to appear
- 6 in the 12th District Court are required to appear before the 369th
- 7 District Court as if originally required to appear before that
- 8 court.
- 9 SECTION 7. The person serving as district attorney for the
- 10 12th Judicial District on September 1, 2013, unless otherwise
- 11 removed from office, continues to serve in that office as
- 12 redesignated as the district attorney for the 369th Judicial
- 13 District for the term to which elected or appointed.
- 14 SECTION 8. This Act takes effect September 1, 2013.
