

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, House Bill No. 912 has been adopted by the house of
2 representatives and the senate and is being prepared for
3 enrollment; and

4 WHEREAS, The bill contains technical errors that should be
5 corrected; now, therefore, be it

6 RESOLVED by the 83rd Legislature of the State of Texas, That
7 the enrolling clerk of the house of representatives be instructed
8 to correct House Bill No. 912, in SECTION 2 of the bill, as follows:

9 (1) In added Section 423.002(a), Government Code, strike
10 "It is lawful to capture an image by an unmanned aircraft" and
11 substitute "It is lawful to capture an image using an unmanned
12 aircraft".

13 (2) In added Section 423.002(a)(4), Government Code,
14 between "(4)" and "by", insert "if the image is captured".

15 (3) In added Section 423.002(a)(5), Government Code,
16 between "(5)" and "by", insert "if the image is captured".

17 (4) In added Section 423.002(a)(8), Government Code,
18 between "(8)" and "by", insert "if the image is captured".

19 (5) In added Section 423.002(a)(9), Government Code,
20 between "(9)" and "by", insert "if the image is captured".

21 (6) In added Section 423.002(a)(13), Government Code,
22 between "(13)" and "by", insert "if the image is captured".

23 (7) In added Section 423.002(a)(17), Government Code,
24 between "(17)" and "by", insert "if the image is captured".

1 (8) In added Section 423.002(a)(17), Government Code,
2 immediately following "related facilities,", strike "if the image"
3 and substitute "and".

4 (9) In added Section 423.002(a)(18), Government Code,
5 following the underlined semicolon, insert "or".

6 (10) In added Section 423.002(a)(19), Government Code,
7 strike the underlined semicolon and substitute an underlined
8 period.

9 (11) Strike added Section 423.008, Government Code, and
10 substitute the following:

11 Sec. 423.008. REPORTING BY LAW ENFORCEMENT AGENCY. (a) Not
12 earlier than January 1 and not later than January 15 of each
13 odd-numbered year, each state law enforcement agency and each
14 county or municipal law enforcement agency located in a county or
15 municipality, as applicable, with a population greater than
16 150,000, that used or operated an unmanned aircraft during the
17 preceding 24 months shall issue a written report to the governor,
18 the lieutenant governor, and each member of the legislature and
19 shall:

20 (1) retain the report for public viewing; and
21 (2) post the report on the law enforcement agency's
22 publicly accessible website, if one exists.

23 (b) The report must include:

24 (1) the number of times an unmanned aircraft was used,
25 organized by date, time, location, and the types of incidents and
26 types of justification for the use;

27 (2) the number of criminal investigations aided by the

1 use of an unmanned aircraft and a description of how the unmanned
2 aircraft aided each investigation;

3 (3) the number of times an unmanned aircraft was used
4 for a law enforcement operation other than a criminal
5 investigation, the dates and locations of those operations, and a
6 description of how the unmanned aircraft aided each operation;

7 (4) the type of information collected on an
8 individual, residence, property, or area that was not the subject
9 of a law enforcement operation and the frequency of the collection
10 of this information; and

11 (5) the total cost of acquiring, maintaining,
12 repairing, and operating or otherwise using each unmanned aircraft
13 for the preceding 24 months.
